On July 16, 2025, the County of Westchester ("County") received and opened five (5) bids for Contract No. 22-515 Resurfacing and Related Improvements to Westchester Avenue, C.R. #112 from Bowman Avenue to Oak Street, A Distance of 0.60 Miles, Village of Port Chester, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Petrillo Contracting, Inc. submitted the low bid in the amount of \$2,246,161.00.

The low bidder has been investigated and it has been found that Petrillo Contracting, Inc.:
