Replacement of Tarrytown Forcemain (Phase II) and Rehabilitation of Route 119 Gravity Sewer

Tarrytown Pumping Station Saw Mill Sanitary Sewer District

Villages of Tarrytown and Elmsford, New York

The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for this project involves replacement of approximately 10,500 linear feet of 30" diameter force main with a new force main pipe. Depending on the chosen route, the approximate 1,300 linear foot section of 30" gravity sewer will either be replaced or rehabilitated. Replacement of the forcemain includes replacement of all piping, valves and all other appurtenances along with relocation of existing utilities and all associated site work. The Tarrytown force main carries sewage approximately 2.75 miles from the Tarrytown Pumping Station in the Village of Tarrytown under pressure to a 0.25-mile gravity sewer section that connects to the Saw Mill Trunk Sewer in the Village of Elmsford.

In accordance with Chapter 635 of the Laws of Westchester County, the Department of Public Works and Transportation has evaluated the needs of this project and determined that a Project Labor Agreement (PLA) will benefit and enhance the interests of the County in the timely and efficient completion of the project. The Contractor to whom this contract is awarded will be required to execute a PLA.

The objective of this contract is to allow the Department of Environmental Facilities to maintain its pump station systems and to ensure continuous and reliable processing of wastewater.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring continued uninterrupted operation of the pump station's wastewater treatment systems. This project will enable the Department of Environmental Facilities to carry out its basic mission to provide wastewater treatment and maintain satisfactory water quality, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

RESOLUTION

RESOLVED, that the Commissioner of Public Works and Transportation be and he hereby is authorized to solicit bids by public advertisement on the following contract:

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
