SUBJECT: Authorization to amend Contract No. 22-219 to change the name of the Contractor from ADT Commercial LLC to Everon, LLC

Pursuant to a Resolution approved on June 8, 2023 (the "June 8<sup>th</sup> Resolution"), the County of Westchester (the "County") entered into Contract No. 22-219 ("Contract") with ADT Commercial LLC ("Contractor"), 6 Skyline Drive, Hawthorne, New York 10532, wherein the Contractor was to provide all necessary labor, material and equipment required to perform testing, inspections and repair services for open protocol fire alarm systems at various County buildings and facilities located throughout Westchester County.

After the approval of the June 8<sup>th</sup> Resolution, the Department was notified by letter dated July 18, 2024 that ADT Commercial LLC has formally changed its company name to Everon, LLC. We were advised that this is a name change only and the same personnel will be used to perform the work thus guaranteeing continuity throughout the Contract. Therefore, approval is requested to amend Contract No. 22-219 to reflect the Contractor's new name.

Approvat of this name change is in the County's best interest, as it will provide for uninterrupted maintenance and testing services of vital life safety systems.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing a safe and code compliant work environment at various County facilities.
