Subject: Authority for the County of Westchester to consent to the assignment of an

agreement with Careers Support Solutions, Inc., for the provision of community mental health services, for a term commencing on January 1, 2022 and continuing through December 31, 2026, to Opengate, Inc.

By resolution approved on December 16, 2021, your Honorable Board authorized the County of Westchester (the "County"), acting by and through its Department of Community Mental Health (the "Department") to enter into an agreement (Contract No. CMH2022004; the "Agreement") with Careers Support Solutions, Inc. (the "Careers Support Solutions"), pursuant to which the Careers Support Solutions agreed to provide community mental health services, for a term commencing on January 1, 2022 and continuing through December 31, 2026, for an amount not-to-exceed \$782,683.00, payable pursuant to an approved budget. The Agreement was subsequently executed.

By email (ated October 15, 2025, Careers Support Solutions informed the Department that it had entered into an Amended and Restated Asset Transfer Agreement, dated April 17, 2025 (the "Transfer Agreement"), with Opengate, Inc. ("Opengate"), pursuant to which Careers Support Solutions agreed to transfer, assign, convey and deliver substantially all of its assets to Opengate, including, but not limited to, the Agreement, and requested that the County consent to the assignment of the Agreement to Opengate (the "Assignment Agreement"). Accordingly, authority is respectfully requested of your Honorable Board to authorize the County to consent to the assignment of the Agreement from Careers Support Solutions to Opengate, effective upon closing of the Transfer Agreement.

All other terms and conditions of the Agreement shall remain in full force and effect.

Accordingly, I most respectfully recommend the adoption of the attached Resolution.
