York, acting for and on behalf of the State University of New York College at Plattsburgh, for the operation of a supervised clinical education and instruction program in social work for State University of New York College at Plattsburgh students, for the term of September 14, 2025 through September 13, 2029.

Authority is respectfully requested from your Honorable Board for the County of Westchester (the "County"), esting by and through its Department of Social Services ("DSS"), is hereby authorized to enter into an affiliation agreement (the "Agreement"; DSS2001HR-25) with the State University of New York ("SUNY"), acting for and on behalf of the State University of New York College at Plattsburgh ("SUNY Plattsburgh"), pursuant to which the County shall participate in a supervised clinical education and instruction program for matriculated SUNY Plattsburgh students, for a term from September 14, 2025 through September 13, 2029, with each party having the right to sooner terminate the proposed Agreement, upon written notice. Under the proposed Agreement, there would be no monetary cost paid to SUNY or SUNY Plattsburgh by the County.

DSS has been advised that SUNY Plattsburgh offers a number of educational programs, including a program in the field of social work. In connection with its social work program, SUNY Plattsburgh has requested that the County enter into the proposed Agreement, in order to provide clinical education and instruction for matriculated SUNY Plattsburgh students who are pursuing a degree in social work. Pursuant to the terms of the proposed Agreement, SUNY Plattsburgh will assign students to DSS, who will then learn on-site in furtherance of their coursework.

The proposed Agreement will serve a public purpose by assisting a public university in preparing students to provide services in the social services workforce, by providing students with practice directly in the field of social work.
