- .P. SECRETARY SECRETARY Resolution authorizing a first amendment wan agreement between the SUBJECT: County of Westchester, Nelson J. Ortiz and Madelyn M. Ortiz aka Madelyn Gil and Altavista Lead Improvement, the rehabilitation of the property located at 13 Normandy Road in the City of Yonkers in order to change the expiration date from October 14, 2024 to December 31, 2024.

On February 29, 2024, the County of Westchester ("County") entered into a "short form" agreement (approved by Short Form (1)# 68023) with Nelson J. Ortiz and Madelyn M. Ortiz aka Madelyn Gil and Altavista Lead Improvement, Inc. ("Altavista"), pursuant to which Altavista agreed to rehabilitate the property located at 13 Normandy Road in the City of Yonkers for the period from October 15, 2023 through October 14, 2024 for an amount not-to-exceed \$25,000 (the "Agreement").

The parties now desire to amend the Agreement in order to change the expiration date thereof from October 14, 2024 to December 31, 2024. The need to extend the term is necessary because there was a delay in receiving the required approvals from the City of Yonkers for this project.

The goal and objective of this Agreement is to provide a safe and healthy environment for the tenants who reside at this property. The project will be monitored by Planning Department staff who will make site visits during construction, as well as monitor the repairs to ensure they meet contractual obligations.

I recommend approval of this amendment.

RESOLVED: that the County Executive or his duly authorized designee is authorized to execute any documents and take any actions necessary to effectuate the purposes hereof.
