SUBJECT: Authority for the County of Westchester (the "County"), acting on behalf of the Westchester-Putnam Local Workforce Development Board, to further amend a resolution approved on December 14, 2023 (the "December 14th Resolution"), as amended on April 24, 2025 (the "April 24th Resolution"), which together authorized the County to enter into an agreement with each of the twenty-two (22) training providers listed in the December 14th and April 24th Resolutions, pursuant to which each provider would provide vocational training services to adult, dislocated workers, and youth pursuant to the provisions of Title I of the Workforce Innovation and Opportunity Act of 2014 for the period from July 1, 2023 through June 30, 2027, for a total aggregate amount not-to-exceed \$2,125,704, by adding one additional training provider, Westchester Barber Academy, Inc. to the list of training providers authorized to provide these services, thereby increasing the total number of training providers from twenty-two (22) to twenty-three (23).

By resolution approved on December 14, 2023, your Honorable Board authorized the County of Westchester, acting on behalf of the Westchester-Putnam Local Workforce Development Board, (the "County") to enter into an agreement with each of the sixty-six (66) training providers listed in the December 14th Resolution, pursuant to which each provider would provide vocational training services to adult, dislocated workers, and youth pursuant to the provisions of Title I of the Workforce Innovation and Opportunity Act of 2014 ("WIOA"), for the period from July 1, 2023 through June 30, 2027, for a total aggregate amount not-to-exceed \$857,901.

Thereafter, by resolution approved on April 24, 2025 (the "April 24th Resolution"), your Honorable Board authorized the County to amend the December 14th Resolution by 1) adding six (6) new training providers to the list set forth in the December 14th

Resolution; 2) increasing the aggregate not-to-exceed amount by \$1,267,803 to a new aggregate not-to-exceed amount of \$2,125,704; 3) rescinding 50 training providers from the list set forth in the December 14th Resolution; and 4) correcting the vendor name of one of the providers on the list set forth in the December 14th Resolution.

Authority is now requested to add one additional training provider, Westchester Barber Academy, Inc., to the list of training providers authorized to provide vocational training services to adult, dislocated workers, and youth pursuant to the provisions of Title I of the Workforce Innovation and Opportunity Act of 2014 for the period from July 1, 2023 through June 30, 2027. While the training provider was among the fifty (50) rescinded on the April 24th resolution, they've since expressed interest in contracting with the County and the decision to rescind them from the original list was a clerical error.

Except as otherwise specifically amended hereby, all remaining terms and conditions set forth in the December 14th Resolution, as amended by the April 24th Resolution, shall remain the same.

I respectfully recommend the adoption of the attached Resolution.
