and the Village of Croton-on-Hudson for a playground and basketball court

replacement project at Dobbs Park.

The attached resolution, if approved by your Homrable Board, would authorize the County of Westchester (the "County") to enterinto an agreement with the Village of Croton-on-Hudson (the "Village"), pursuant to which the Village will perform a playground and basketball court replacement project (the "Project") at Dobbs Park. In consideration for performing the Project, the County will pay the Village an amount not to exceed \$200,000, to be paid in community Development Block Grant funding, pursuant to an approved budget. The agreement will commence on June 2, 2025 and continue through June 1, 2026.

The Project includes the eplacement of the current playground equipment with new inclusive playground equipment, replace the existing pathway and resurface the basketball court and other associated work.

The goal and objective of the Project is to create a safe environment for users of the park by replacing the aging playground equipment with new inclusive playground equipment, existing pathway and resurface the basketball court. The Project will be monitored by the Village's Public Works Department and Westchester County Department of Planning staff who will make site visits to ensure all contractual requirements are met.

This procurement is in compliance with the County of Westchester Procurement Policy Procedures, pursuant to Section 3(a)xvi, which exempts contracts with recipients for disbursement of grants or loans under the Community Development Block Grant Program.

Act # 141-2024, adopted August 5, 2024, by the Westchester County Board of Legislators, authorizes the County to submit an Urban County Application under the Federal Community Development Block Grant, Emergency Solutions Grant, and HOME Investment Programs, including a FY 2024-2028 Consolidated Plan to include the FY 2024 Action Plan and to accept such Grants.

RESOLVED: that in consideration for performing said services, the County shall pay the Village a not to exceed amount of \$200,000 in Community Development Block Grant Program funding, to be paid pursuant to an approved budget; and be it further

RESOLVED: that the County Executive or his duly authorized designee is authorized to execute any documents and take any actions necessary to effectuate purposes hereof.
