RE: Authority to enter into a first amendment to a grant agreement for the Second

Statewide Expansion of Hurrell-Harring grant with the New York State Office of

Indigent Legal Services to improve the quality of mandated indigent legal services in order to increase the amount of the grant from \$8,451,219.48 to

\$8,958,292.65 and to enter into a first amendment to an agreement with The Legal

Aid Society of Westchester County

On October 31, 2024, your Honorable Board approved a resolution authorizing the County of Westchester (the "County") to enter into a grant agreement (the "Grant Agreement") for the Second Statewide Expansion of Hurrell-Harring grant with the New York State Office of Indigent Legal Services ("ILS") for the receipt of \$8,451,219.48 to improve the quality of indigent legal services provided by the County for the period April 1, 2024 through March 31, 2027 and to enter into an agreement with The Legal Aid Society of Westchester County ("The Legal Aid Society") to implement a portion of the County's indigent legal services work plan for the Grant Agreement for the period April 1, 2024 through March 31, 2027 (the "Agreement"). A portion of the work plan would be provided by the County Independent Office of Assigned Counsel. The Grant Agreement and Agreement were subsequently executed.

ILS has approved a budget amendment to the Grant Agreement in order to increase the amount of the grant from \$8,451,219.48 to \$8,958,292.65. This budget amendment will increase the funding for The Legal Aid Society from an amount not to exceed \$3,421,769.34 to an amount not to exceed \$3,649,002.51. The amount allocated to the County Independent Office of Assigned Counsel will be increased from an amount not to exceed \$5,029,450.14 to an amount not to exceed \$5,309,290.14. The work plan for the Grant will be amended to reflect this additional funding.

The first amendment to the Grant Agreement and the Agreement will serve a public purpose in that they will enable the County to improve its lawful obligation of providing counsel to certain indigent persons. The goals and objectives are to ensure that effective counsel is provided in a cost efficient manner. The goals and objectives will be tracked and monitored by the County Budget Office.

The first amendment to the Grant Agreement not a procurement so the County's Procurement Policy and Procedures does not apply. The first amendment to the Agreement Aid Society is exempt from the County's Procurement Policy and Procedures pursuant to Section 3(a)xiv.
