E) RATHOND SCULKY, SECRETARY On September 10, 2025, the County of Westchester ("County") received and opened one (1) bid for Contract No. 24-507 for Replace Bus Wash System, Alphonse J. Cerrato Bus Maintenance Facility, Grasslands Campus, Valhalla, New York.

One (1) contractor submitted a bid for this project. The project was advertised on the Empire State Purchasing Group website, in addition to the Journal News (Westchester-Putnam Edition), and was viewed by ninety (90) entities on the Empire State Rurchasing Group website. In addition, emails were sent to those ninety (90) entities and to an additional one thousand seven hundred and one (1,701) suppliers and contractors.

The bid was reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Mace Contracting Corporation (MBE) submitted the sole bid in the amount of \$3,700,000.00. Mace Contracting Corporation (MBE) has proposed the use of the following subcontractor: Naber Electric Corp. (Electrical), 1025 Saw Mill River Road, Yonkers, New York 10710.

The sole bidder has been investigated and it has been found that Mace Contracting Corporation (MBE):
