On February 11, 2026, two (2) bids were received and opened for Contract No. PRC-1496 for Service Contract for Sweeping and Litter Removal Services at Playland Park and after select events at Kensico Dam Plaza for the Department of Parks, Recreation and Conservation Westchester County, New York.

Two (2) contractors submitted bids for this project. The project was advertised in the Journal News (Westchester-Putnam Edition), and was posted and viewed by sixteen (16) entities on the BidNet Direct website.

The bids were reviewed by the Department and it was determined that East Coast Industrial Services, Inc. submitted the low bid in the amount of \$944,500.00.

The bidder has been investigated and it has been found that East Coast Industrial Services, Inc.:

- Performed satisfactory work in the past for the County.
- Past experience has been investigated and found satisfactory.

Funds for this project are available in the:

- Capital Budget
- Non-Recurring Budget
- Operating Budget

The objective of this contract is to keep both Playland Park and Kensico Dam Plaza clean through pavement sweeping and litter removal services.

This contract is in the public's best interest because it will promote a clean, healthy and safe place to enjoy the park and the events held there.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

This contract is for a term of five years from May 1, 2026 through April 30, 2031.

It is my recommendation that Contract No. PRC-1496 be awarded to East Coast Industrial Services, Inc. in the amount of \$944,500.00 subject to appropriations

RESOLUTION

Upon a communication from the Commissioner of Parks, Recreation and Conservation, be it hereby

RESOLVED, that Contract No. PRC-1496 for Service Contract for Sweeping and Litter Removal Services at Playland Park and after select events at Kensico Dam Plaza for the Department of Parks, Recreation and Conservation, Westchester County, New York is hereby awarded to the low bidder, East Coast Industrial Services, Inc., P.O. Box1069 Pine Bush, New York 12566 in the amount of \$944,500.00; and be it further

RESOLVED, that as set forth in the Contract No. PRC-1496 bid specifications this contract is for a term of five (5) years from May 1, 2026 through April 30, 2031; and be it further

RESOLVED, that this contract is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
