RCJ Welding & Fabricating LLC is being requested to do Steel Work Roof D and Associates Work. It should be noted Armor-Tite canvassed Universal Construction Inc., an MBE firm; A & T Iron Works, Inc., a WBE firm; and County Fabricators, LLC, a WBE firm; but the firms did not respond to Armor-Tite's inquiry.
