SUBJECT: Authority to amend each of thirty-four (34) agreements, pursuant to each of which each entity was to provide certain community mental health services, for a term continuing through December 31, 2026, for various not-to-exceed amounts, by increasing the not-to-exceed amount of each agreement, by various individual amounts and a total aggregate increase of \$36,813,006.00.

By a resolution approved on December 16, 2021, your Honorable Board authorized the County of Westchester (the "County"), acting by and through its Department of Community Mental Health (the "Department"), to enter into an agreement, pursuant to Articles 25 and 41 of the New York State Mental Hygiene Law, with each of the forty (40) entities listed below, pursuant to each of which each entity would provide certain community mental health services, including services to mentally ill adults, services to seriously emotionally disturbed children and adolescents, services to mentally/developmentally disabled individuals, drug free treatment services, methadone maintenance treatment services, alcoholism treatment services and/or school-based alcohol and substance abuse prevention services, for a total aggregate amount not-to-exceed \$227,863,434.00 and for the various individual not-to-exceed amounts specified below, with each agreement being for the period from January 1, 2022 through December 31, 2026 (collectively, the "40 Agreements"):

The 40 Agreements were subsequently executed.

By a resolution approved on March 13, 2025, your Honorable Board authorized the County, acting by and through the Department, to enter into an agreement with Independent

Living, Inc. (“IL”), pursuant to which IL was to provide certain community mental health services, for the period from January 1, 2025 through December 31, 2026, for an amount not-to-exceed \$1,023,750.00 (the “IL Agreement”). The IL Agreement was subsequently executed.

By resolutions approved on November 10, 2022, June 29, 2023, May 8, 2025, December 5, 2024, September 5, 2024, October 27, 2022, and April 3, 2025, your Honorable Board authorized the County to modify seven (7) of the 40 Agreements, with, respectively, the entities listed below, for various respective purposes, including increasing the not-to-exceed amount of each agreement, by the respective amounts listed below, to the respective new total not-to-exceed amounts listed below, and a total aggregate increase of \$5,686,660.00 (the “7 Amendments”):

The 7 Amendments were subsequently executed.

By resolutions approved on October 27, 2022 and October 5, 2023, your Honorable Board authorized the County to enter into two (2) separate amendments to the agreement with Lexington Center For Recovery, Inc. (“Lexington”) that was among the 40 Agreements, for various respective purposes, including increasing the not-to-exceed amount of the agreement by, cumulatively, \$1,355,088.00, to a new total not-to-exceed amount of \$10,032,831.00 (the “Lexington Amendments”). The Lexington Amendments were, one after the other, subsequently executed.

The not-to-exceed amount of each of the 40 Agreements, as amended by the 7 Amendments and the Lexington Amendments, and the IL Agreement (collectively, the “Current Agreements”) was based upon certain original financial projections, which incorporated estimated, anticipated, future-year cost-of-living adjustments (“COLAs”) and/or Supported Housing Rental Assistance bed stipends (“Stipends”). Both the COLAs and the Stipends, however, ultimately included increases that exceeded these initial estimates that were included in the respective not-to-exceed amounts of the Current Agreements. In addition, “Targeted Inflationary Increase” (“TII”) was developed post-2021 as a pandemic-era relief mechanism to address rising operational costs and workforce shortages in not-for-profit mental health programs, and was not accounted-for in the various not-to-exceed amounts, as it was unknown to the County at the time.

Accordingly, the County now desires to account for the increases in the COLAs, the increases in the Stipends, and the TII funds, (collectively, the “Additional Funds”) in various of the Current Agreements.

For administrative purposes, the County is required to have only one (1) agreement with each provider of the type of community mental health services that are provided under the Current Agreements. Accordingly, in order to make the Additional Funds available under various of the Current Agreements, each of the impacts Current Agreements must be amended, rather than a new, separate agreement be entered into.

Therefore, the County respectfully requests authority from your Honorable Board to amend each of the Current Agreements specified below, by increasing the not-to-exceed amount of each such agreement, by the respective amounts listed below, to the respective new total not-to-exceed amounts listed below, and a total aggregate increase of \$36,813,006.00 (the “34 Amendments”):
