The 2025 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for the replacement and upgrading of various process systems at the Mamaroneck Water Resource Recovery Facility in Mamaroneck, New York to help restore the existing systems to their intended functions and improve the operation and efficiency of the treatment facilities. The systems requiring replacement and/or upgrading include, but are not limited to, the entire electrical distribution system including the main switchgear and the addition of a second standby electrical generator to provide full electrical redundancy; the rehabilitation of the wet mist scrubbers and the replacement of the associated chemical feed systems in the Odor Control System. Other system replacements include the submersible mixers in the Aeration Tanks as well as the replacement of the Process Air Blowers to improve their reliability and efficiency.

In accordance with Chapter 635 of the Laws of Westchester County, the Department of Public Works and Transportation has evaluated the needs of this project and determined that a Project Labor Agreement (PLA) will benefit and enhance the interests of the County in the timely and efficient completion of the project. The Contractor to whom this contract is awarded will be required to execute a PLA.

The objective of this project will be the replacement and upgrade of various Electrical Generation equipment and related systems.

This contract is in the public's best interest because it ensures that the facility meets ongoing operational needs and complies with current building codes.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
