SUBJECT:	Authorization to extend the term of Agreement No. 17-930 with H2M Architects, Engineers, Land Surveying and Landscape Architecture, D.P.C. d/b/a H2M architects + engineers retroactively from December 31, 2024 until December 31, 2028

Authority of your Honorable Board is requested to extend the term of Agreement No. 17-930 ("Agreement") between the County of Westchester ("County") and H2M Architects, Engineers, Land Surveying and Landscape Architecture, D.P.C. d/b/a H2M architects + engineers ("Consultant"), 538 Broad Hollow Road, 4th Floor East, Melville, New York 11747, in connection with engineering services for the Phase I and Phase II Roof Replacement Program, Port Chester Water Resource Recovery Facility, Port Chester, New York, retroactively from December 31, 2024 until December 31, 2028. The original Agreement dated January 11, 2018, wherein the Consultant was to provide design and construction administration services associated with the Phase I Roof Replacement Program, Mamaroneck, Peekskill, and Port Chester Water Resource Recovery Facilities was for a total amount not to exceed \$694,272.46. The Original Agreement completion date was December 31, 2022.

The Agreement was thereafter amended pursuant to a Resolution approved August 2, 2018, ("First Amendment") to provide for: (1) additional design services of solar panels associated with the Phase I Roof Replacement Program at Mamaroneck, Peekskill, and Port Chester Water Resource Recovery Facilities; (2) design and construction administration services associated with the Phase II Roof Replacement Program at Yonkers Joint Water Resource Recovery Facility, Yonkers, New York and (3) ) extending the completion date of the Agreement to December 31, 2023. The Agreement fee was increased by an additional \$836,000.00 to an amended amount not-to-exceed \$1,530,272.46.

The Agreement was thereafter further amended pursuant to a Resolution approved April 30, 2020, ("Second Amendment") to provide for additional design and construction administration services associated with Phase II Roof Replacement Program, Yonkers Joint Water Resource Recovery Facility, Yonkers, New York. The Agreement fee was increased by an additional \$252,500.00 to an amended amount not-to-exceed \$1,782,772.46. The Agreement completion date was extended to December 31, 2024.

The engineering services included in the original Agreement have been in progress. The County has been satisfied with the quality of services provided to date. However, coordination with other projects at the facility has caused a delay in overall design completion. A construction contract will be going out to bid shortly and subsequently awarded. Therefore, the professional services of the Consultant will be required beyond December 31, 2024 in order to provide the remaining engineering services and construction administration services associated with the project.

Authority of your Honorable Board is therefore requested to further amend the existing Agreement with the Consultant to extend the end date of the Agreement retroactively from December 31, 2024 until December 31, 2028 with no increase in the not-to-exceed amount of \$1,782,772.46.

RESOLVED, that the County of Westchester ("County"), acting by and through its Department of Public Works and Transportation ("Department"), be and is hereby authorized to further amend Agreement No 17-930 ("Agreement") with H2M Architects, Engineers, Land Surveying and Landscape Architecture, D.P.C. 2/b/a H2M architects + engineers ("Consultant"), 538 Broad Hollow Road, 4<sup>th</sup> Floor East, Melville, New York 11747, in connection with engineering services for the Phase I and Phase II Roof Replacement Rehabilitation, Port Chester Water Resource Recovery Facility, Port Chester, New York by extending the term retroactively from December 31, 2024 until December 31, 2028; and be it further

RESOLVED, that all other terms and conditions of the Agreement, including the not to exceed amount of \$1,782,772.46 shall remain the same; and be it further

RESOLVED, that all other provisions of the existing Agreement shall remain in full force and effect; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
