Authority is respectfully requested from your Honorable Board for the County of Westchester (the "County") to enter into a grant agreement (DSS3044-25) with the United States Department of Housing and Urban Development ("NYSDOT"), and thereby accept a grant, for the period from March 1, 2025 through February 28, 2026, in an amount not-to-exceed \$665,247.00, being made available to the County to pay for a 'Continuum of Care' program concerning 'Coordinated Entry' data (the "Grant Agreement": NY1050L2T042409).
