SCULK, SECRETARY Authority to amend an agreement with the National Association for the Advancement of Re: Colored People, for services, by its Peekskill branch, to provide tobacco education programs, for the period from November 1, 2023 through October 31, 2024, by, 1.) extending its term by two (2) months, to a new expiration date of December 31, 2024, without any increase in its existing \$35,000.00 not-to-exceed amount; and 2.) correcting the name of the contractor within the agreement.

By a 'short form' authorization fully approved on January 24, 2024 (SFC #69401), the County of Westchester (the "County") was authorized to enter into an agreement with the National Association for the Advancement of Colored People (the "NAACP"), pursuant to which the Peekskill branch of the NAACP was to perform services to provide tobacco education programs (the "Services"), for the period from November 1, 2023 through October 31, 2024, for a total amount not-to-exceed \$35,000.00, payable pursuant to an approved budget (the "Agreement"). The Agreement was subsequently executed.

The NAACP recently requested an additional two (2) months to fully perform the Services, without any increase in the existing \$35,000.00 not-to-exceed amount of the Agreement. The County is agreeable to providing the NAACP with the additional time that it has requested.

Due to an administrative matter, the Agreement recites a different corporate name than the NAACP's actual, legal corporate name. The County, therefore, desires to correct this situation.

Accordingly, the County respectfully requests authority from your Honorable Board to amend the Agreement by, 1.) extending its term by two (2) months, to a new expiration date of December 31, 2024, and 2.) correcting the name of the contractor within the Agreement, to "National Association for the Advancement of Colored People, doing business as NAACP Peekskill NY Branch 2170" (the "First Amendment").

Except as specifically described above, all terms and conditions of the Agreement shall remain in full force and effect.

The proposed First Amendment will serve a public purpose by ensuring that the County is provided with the Services for which it contracted, by providing the NAACP with additional time for its performance.

RESOLVED, that the County of Westchester (the "County") is hereby authorized to amend its agreement with the National Association for the Advancement of Colored People (the "NAACP"), pursuant to which the Peekskill branch of the NAACP was to perform services to provide tobacco education programs to LGBTQ+ youths (the "Services"), for the period from November 1, 2023 through October 31, 2024, for a total amount not-to-exceed \$35,000.00, payable pursuant to an approved budget, (the "Agreement") by. 1.) extending its term by two (2) months, to a new expiration date of December 31, 2024, and 2.) correcting the name of the contractor within the Agreement, to "National Association for the Advancement of Colored People, doing business as NAACP Peekskill NY Branch 2170" (the "First Amendment"); and be it further

RESOLVED, that except as hereby authorized to be amended, all terms and conditions of the Agreement shall remain in full force and effect; and be it further resolved; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions reasonably necessary and appropriate to effectuate the purposes of this resolution.
