On May 15, 2024, four (4) bids were received for Contract No. 22-502 New Salt Storage Shed Facilities, Croton Point Park, Lasdon Park, and Sprain Ridge Park, Village of Croton-on-Hudson, Town of Somers and City of Yonkers, New York.

The bids exceeded the amount budgeted for this project. The Department of Public Works and Transportation is reviewing the contract documents to reduce the overall scope of work in order to reduce costs.

Therefore, authority is requested to reject the bids and re-advertise as Contract No. 22-502-Rev.

The objective of this contract is to construct additional salt sheds which are strategically located in the County to assist in the serviceability of salting the County's roads.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the facility's operations are safe and environmentally compliant, thereby enhancing the general welfare of the residents of the County.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
