SECRETARY SECRET Authorization to amend a grant agreement with the New York State Division of SUBJECT:

Homeland Security and Emergency Services, for the acceptance of \$1,409,862.00 in federal grant funds to, among other things, enhance the County's capability to prevent terrorist attacks and mitigate against man-made and natural hazards, protect the people of the County and the County's critical infrastructure and key resources, in compliance with the FY2022 Urban Areas Security Initiative grant program, for the period September 1, 2022 through August 31, 2025, in order to retroactively extend the term thereof by one year, until August 31, 2026, modify certain budget line item costs and expenses and

revise certain Grant goals and objectives.

By resolution adopted by your Honorable Board on October 13, 2022, the County of Westchester (the County"), acting by and through its Department of Emergency Services (the "Department"), was authorized to enter into a grant agreement – DHSES WM22190201/Project No. UN22-1002-D00 (the "Grant Agreement") with the New York State Division of Homeland Security and Emergency Services (the "State") to accept federal grant funds in an amount not-toexceed \$1,409,862.00 under the State's FY2022 Urban Areas Security Initiative grant program ("FY2022 UASI Grant Program"), to assist the County of Westchester in its efforts to address equipment, training and planning needs to enhance the County's capability to prevent terrorist attacks, including combating domestic violence extremism through Active Shooter/Hostile Event ("ASHE") training, and mitigate against man-made and natural hazards, protect the people of the County, the County's critical infrastructure and key resources, and prepare to respond to and recover from both man-made and natural disasters. The term of the Grant Agreement was for a period from September 1, 2022 through August 31, 2025. The Grant Agreement was executed.

Authority is now respectfully requested to amend the Grant Agreement ("Grant Amendment – Project UN22-1002-D01" or "Grant Agreement") in order to (1) retroactively extend the term thereof by one year, from September 1, 2025 through August 31, 2026; (ii) modify certain budget line item costs and expenses; and (iii) supplement certain Grant goals and objectives by increasing funding for equipment purchase and enhancement capabilities. The terms of the Grant Amendment supersede the terms of the Grant Agreement.

Pursuant to the Grant Amendment, Westchester is to continue to fund certain projects from previous grant years including, but not limited to, the development, sustainment and/or enhancement of interoperable communications equipment, focusing on enhancing public health readiness by strengthening preparedness planning and improving environmental monitoring capabilities, sustainment of regional response teams including HazMat and Technical Rescue, critical infrastructure protection and support the enhancement and sustainment of Mass Casualty Incident (MCI) equipment response capabilities with greater emphasis on equipment purchase and enhancement capabilities to better assess the vulnerability of and/or harden/protect critical infrastructure and key assets.

All other provisions of the Grant Agreement that do not conflict with the terms of the Grant Amendment will remain in full force and effect.

The goals and objectives of this Grant Agreement, as amended by the Grant Amendment are to address vulnerabilities and develop capabilities to meet target capabilities as outlined in the federal Homeland Security Grant Program guidelines. This includes providing assistance to and support for surveillance, detection, interdiction, response, mitigation, operations and recovery from man-made and natural disasters.

This Grant Amendment will serve the public's best interest as it will enhance emergency preparedness and thereby preserve the health, safety and general welfare of County residents.

The Department will monitor the progression of the work plan associated with the Grant Amendment to ensure compliance and progress in meeting the goals and objectives of this program and will monitor the effectiveness of this Grant Amendment through a series of performance measures required by the State.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

In view of the importance of this program, I recommend approval of the attached resolution.

**RESOLVED**, that the County of Westchester (the "County"), acting by and through its Department of Emergency Services, is authorized to amend the grant agreement of DHSES WM22190201/Project No. UN22-1002-D00 ("Grant Amendment") in an amount not-to-exceed \$1,409,862.00 under the State's FY2022 Urban Areas Security Initiative grant program ("FY2022 UASI Grant Program"), in order to (1) retroactively extend the term thereof by one year, from September 1, 2025 through August 31, 2026; (ii) modify certain budget line item costs and expenses; and (iii) revise certain Grant goals and objectives by increasing funding for equipment purchase and enhancement capabilities to better assess the vulnerability of and/or harden/protect critical infrastructure and key assets; and be it further

**RESOLVED**, that the terms of the Grant Amendment shall supersede the terms of the Grant Agreement. All other provisions of the Grant Agreement that do not conflict with the terms of the Grant Amendment shall remain in full force and effect.

**RESOLVED**, that the County Executive or his authorized designee is authorized and empowered to execute and deliver all instruments and take all actions necessary or appropriate to effectuate the purposes hereof.
