On July 25, 2024, your Honorable Board awarded Contract No. 22-511-Rev., Parking Garage Rehabilitation – Phase II, Michaelian Office Building, 148 Martine Avenue, White Plains, New York to Mace Contracting Corporation (MBE), 411 5th Avenue, New Rochelle, New York 10801 in the amount of \$34,874,750.00.

After the approval of the July 25, 2024 Resolution, the Department of Public Works and Transportation became aware that the subcontractor named by Mace Contracting Corporation (MBE) in its Bid for the Contract work was inadvertently omitted from the Award Resolution.

Therefore, it is hereby requested that the Resolution approved July 25, 2024 authorizing the award of Contract No. 22-511-Rev. between the County of Westchester and Mace Contracting Corporation (MBE) be amended to reflect D&M Electrical Contracting as an approved subcontractor.
