SUBJECT: Authority to exercise the County's option to extend the term of an agreement with Picco Construction LLC for one two (2) year option period, thereby increasing the amount of the agreement by \$92,700.00 and extending the term of the agreement through October 28, 2028 (Contract No. 23-205)

By resolution approved on August 17, 2023 (the "August 17, 2023 Resolution"), your Honorable Board awarded Contract No. 23-205 to Picco Construction LLC. ("Picco"). The August 17, 2023 Resolution authorized the County of Westchester (the "County") to enter into Contract No. 23-205 with Picco, pursuant to which Picco was to provide a Service Contract for Snow and Ice Removal, 100 East First Street, Mount Vernon, New York in the amount of \$139,500.00, for the period from October 29, 2023 through October 28, 2026, ("Contract No. 23-205" or the "Agreement"), with the County having the sole option to extend the Agreement for one (1) two (2) year option period.

The County now seeks authority from your Honorable Board to 1) exercise the two (2) year renewal option and extend the termination date of the Agreement from October 28, 2026 to October 28, 2028; and 2) increase the amount of the Agreement by \$92,700.00 from an amount of \$139,500.00 to a new total amount not to exceed \$232,200.00.

All other terms and conditions of the August 17, 2023 Resolution and the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing safe travel ways for both pedestrian and vehicular traffic at County facilities.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

RESOLVED, that the County is authorized to 1) exercise its two (2) year renewal option for Contract No. 23-205 with Picco Construction LLC., Mamaroneck, New York to provide a Service Contract for Snow and Ice Removal, 100 East First Street, Mount Vernon, New York and extend the termination date of the Agreement from October 28, 2026 to October 28, 2028; and 2) increase the amount of the Agreement by \$92,700.00 from an amount of \$139,500.00 to a new amount not to exceed \$232,200.00; and be it further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the August, 17, 2023 Resolution and the Agreement shall remain in full force and effect and unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
