SUBJECT: Authority to exercise the County's two-year option to extend the term of its agreement with AAA Carting & Rubbish Removal, Inc. for Countywide Solid Waste Removal Services, Westchester County, New York, thereby increasing the amount of the agreement by \$1,182,266.67 and extending the term of the agreement through January 11, 2029 (Contract No. 23-210)

By resolution approved on December 7, 2023 (the "December 7th Resolution"), your Honorable Board awarded Contract No. 23-210 to AAA Carting & Rubbish Removal, Inc. ("AAA"). The December 7th Resolution authorized the County of Westchester (the "County") to enter into Contract No. 23-210 with AAA, pursuant to which AAA was to provide Countywide Solid Waste Removal Services, Westchester County, New York, in the amount of \$1,773,400.00, for the period from January 12, 2024 through January 11, 2027, ("Contract No. 23-210" or the "Agreement"), with the County having the sole option to extend the term of the Agreement for one (1) two (2) year option period. The Agreement was subsequently executed.

The County now seeks authority from your Honorable Board to exercise the its two (2) year renewal option, and thereby: 1) extend the termination date of the Agreement from January 11, 2027 to January 11, 2029; and 2) increase the amount of the Agreement by \$1,182,266.67, from an amount not-to-exceed \$1,773,400 to a new total amount not to exceed \$2,955,666.67 (the "First Amendment").

All other terms and conditions of the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by maintaining clean and sanitary conditions.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

RESOLUTION

Upon a communication from the Commissioner of the Department of Public Works and Transportation, be it hereby

RESOLVED, that the County of Westchester is authorized to exercise its two (2) year renewal option for Contract No. 23-210 (the "Agreement") with AAA Carting & Rubbish Removal, Inc. (WBE), Buchanan, New York, to provide Countywide Solid Waste Removal Services, Westchester County, New York and thereby: 1) extend the termination date of the Agreement from January 11, 2027 to January 11, 2029; and 2) increase the amount of the Agreement by \$1,182,266.67, from an amount not-to-exceed \$1,773,400.00 to a new total amount not to exceed \$2,955,666.67; and be it further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the Agreement shall remain in full force and effect and unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
