On August 13, 2025, the County of Westchester ("County") received and opened eleven (11) bids for Contract No. 23-511 for Bronx River Pathway Reconstruction, Bronx River Reservation from Kensico Dam Plaza to Greenacres Avenue, City of White Plains, Towns of Greenburgh and North Castle and Village of Scarsdale, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Peter J. Landi Inc. submitted the low bid in the amount of \$8,765,675.00.

The low bidder has been investigated and it has been found that Peter J. Landi Inc.:
