RE: **AUTHORITY TO AMEND THE RESOLUTION APPROVED ON JUNE 26, 2025, WHICH AUTHORIZED THE COUNTY OF WESTCHESTER TO ENTER INTO AN AGREEMENT WITH HKA GLOBAL, INC., TO CONDUCT TAX FRAUD INVESTIGATIONS, FOR THE PERIOD FROM JANUARY 1, 2025 THROUGH DECEMBER 31, 2025, IN AN AMOUNT NOT TO EXCEED \$52,430.00, IN ORDER TO REFLECT THE CORRECT LEGAL NAME OF THE CONSULTING PARTY AS HKA GLOBAL, LLC.**

By resolution approved on June 26, 2026 (the "June 26th Resolution"), your Honorable Board authorized the County of Westchester (the "County"), acting by and through its Office of the District Attorney ("DA's Office"), to enter into an agreement with HKA Global, Inc., to conduct tax fraud investigations as part of the DA's Office's operation of the Crimes Against Revenue Program, for the period from January 1, 2025 through December 31, 2025, in an amount not to exceed \$52,430.00 (the "Agreement"). The Agreement has not yet been executed.

The County has been notified that the legal name of the consulting party is now HKA Global, LLC. Accordingly, authority is now respectfully requested to amend the June 26th Resolution for the limited purpose of reflecting the correct legal name of the consulting party as HKA Global, LLC.

Except as specifically amended hereby, all remaining terms and conditions contained in the June 26th Resolution shall remain in full force and effect.
