RE: Authority to amend an agreement with Cellco Partnership, a Delaware general partnership, doing business as Verizon Wireless, for cellular telephone and wireless data services, for a total amount not-to-exceed \$3,600,000.00, for the period commencing on September 16, 2019 and continuing until the termination date of New York State Office of General Services Contract Number PS68692, which has now been extended through September 15, 2029, by increasing its not-to-exceed amount by \$9,200,000.00, to a new total not-to-exceed amount of \$12,800,000.00, in order to pay for services during the full term of the agreement.

By a resolution approved on November 7, 2019, your Honorable Board authorized the County of Westchester (the "County") to enter into an agreement with Cellco Partnership, a Delaware general partnership, doing business as Verizon Wireless, for cellular telephone and wireless data services (the "Services"), for the period commencing on September 16, 2019 and continuing until the termination date of New York State Office of General Services ("OGS") contract PS68692, for a total amount not-to-exceed \$3,600,000.00, payable monthly and as otherwise required by PS68692 (the "Agreement"; IT-1579). The Agreement was subsequently executed.

By a 'Contract Award Notification Update' dated September 18, 2024, OGS extended the term of PS68692 by five (5) years, through September 15, 2029. Accordingly, the term of the Agreement was, likewise, extended, to that new, later termination date.

Therefore, authority is now respectfully requested from your Honorable Board for the County to amend the Agreement by increasing its not-to-exceed amount by \$9,200,000.00, to a new total not-to-exceed amount of \$12,800,000.00, in order to pay for the Services during the full term of the Agreement (the "First Amendment").

Except as specifically described above, all terms and conditions of the Agreement shall remain in full force and effect.

The proposed First Amendment will serve a public purpose by ensuring that the County continues to have the Services that are necessary for its staff to have communication devices that enable them to do their jobs more efficiently.
