Bet Resolution Authorizing an Agreement Between the County of Westchester SUBJECT:

and the Town of Cortlandt for the replacement of the playground at

Cortlandt Waterfront Park.

The attached resolution, if approved by your Honorable Board, would authorize the County of Westchester (the "County") to enter into an agreement with the Town of Cortlandt (the "Town"), pursuant to which the County will conduct an in kind replacement of the playground equipment at the Cortlandt Waterfront Park (the "Project"). In consideration for performing the Project, the County will pay the Town an amount not to exceed \$260,000, to be paid in Community Development Block Grant funding, pursuant to an approved budget. The agreement will commence on September 1, 2023 to August 30 2024.

The Project incitives the replacement of the playground that has deteriorated over time and has outlived its useful life, and to add a walking path that will connect the existing parking lottor ease of accessibility to the playground.

The goal and objective of the Project is to ensure public health and safety to the low and moderate income residents of the area by the replacement/upgrades of the deteriorated condition of the playground. The Project will be monitored by the Town's Public Works Department and Westchester County Department of Planning staff who will make site visits to ensure all contractual requirements are met.

This procurement is in compliance with the County of Westchester Procurement Policy Procedures, pursuant to Section 3(a)xvi, which exempts contracts with recipients for disbursement of grants or loans under the Community Development Block Grant Program.

Act # 12-2022, adopted June 30, 2022, by the Westchester County Board of Legislators, authorized the County to submit an Urban County Application under the Federal Community Development Block Grant, Emergency Solutions Grant, and HOME Investment Partnership Program, including a FY 2019-2023 Consolidated Plan to include the FY 2022 Action Plan, and to accept such Grants.
