RE:	Authority to amend a resolution approved on March 27, 2025 to correct the name of the licensee from Park & Coast Hospitality Group LLC to Parks & Coast Hospitality Group, LLC, dba, Tiki Beach Pier Restaurant.

By resolution approved on March 27, 2025 (the "March 27th Resolution"), your Honorable Board authorized the County, acting by and through the Department of Parks Recreation and Conservation (the "Department"), to enter into a license agreement with Park & Coast Hospital Group, LLC, for the operation of the Pier restaurant known as Tiki Beach at Playland Park in Rye, New York, as well as the operation of the daily boat parking service utilizing the service dock, ramp and moorings located off the Playland Pier including the operation of a boat shuttle to and from the moorings to a floating dock for a term commencing May 1, 2025 and expiring December 31, 2026 for a license fee as set forth in March 27th Resolution.

Following passage of the March 27th Resolution, the Department learned that the correct corporate name of the licensee is Parks & Coast Hospitality Group, LLC, dba, Tiki Beach Pier Restaurant.

Accordingly, authority is now respectfully requested to amend the March 27th Resolution in order to correct the name of the licensee.

Except as specifically amended hereby, all other terms and conditions set forth in the March 27th Resolution shall remain in full force and effect.
