SUBJECT: Resolution issuing a Negative Declaration pursuant to the requirements of the State Environmental Quality Review Act in connection with the authority to file an application with the New York State Department of Environmental Conservation for a Freshwater Wetlands Permit (Agreement No. 26-917) for the Cranberry Lake Nature Center and Site Work Project at Cranberry Lake Preserve in West Harrison, New York, and in the application agree to indemnify and save harmless the State of New York with regard to the Project.

There is currently pending before your Honorable Board a resolution ("Resolution") authorizing the County of Westchester (the "County"), acting by and through its Department of Public Works and Transportation, to file a Freshwater Wetlands permit ("Permit") application with the New York State Department of Environmental Conservation for the Cranberry Lake Nature Center project (RCL01) and Cranberry Lake Site Work project (RCL02) (collectively, the "Project") in West Harrison, New York and in said application agree to indemnify and save harmless the State of New York from suits, actions, damages and costs of every name and description resulting from said Project.

Prior to your Honorable Board approving said Resolution, the Planning Department has advised that the Project must be reviewed pursuant to the State Environmental Quality Review Act and its implementing regulations ("SEQRA"). The Planning Department has further advised that the project constitutes an "Unlisted" action pursuant to 6 NYCRR Part 617, the implementing regulations of SEQRA. In accordance with SEQRA, a Full Form Environmental Assessment Form ("EAF") and resolution have been prepared and are attached to assist your Honorable Board in complying with SEQRA.

Your Honorable Board should carefully consider the proposed action and review the attached EAF and the criteria contained in Section 617.7 of 6 NYCRR Part 617 to identify the relevant areas of environmental concern.

Once you have thoroughly analyzed the relevant areas of concern, you must determine if the proposed action may have a significant impact on the environment. For the reason set forth in the attached EAF, the Planning Department analysis concludes that the proposed action will not have any significant adverse impact on the environment. The EAF and a resolution in support of this determination of significance are submitted for your review and consideration. Your Honorable Board may utilize the advice and assistance of the Planning Department in making your required determination under the applicable SEQRA regulations.

WHEREAS, this Board has carefully considered the proposed action and has reviewed the attached EAF and the criteria contained in Section 617.7 of 6 NYCRR Part 617 of the SEQRA regulations and has identified the relevant areas of environmental concern as described in the attached EAF to determinate if the proposed action will have a significant impact upon the environment now, therefore, be it

RESOLVED, by the Board of Acquisition and Contract of the County of Westchester, State of New York, that based upon this Board’s review of the EAF and for the reasons set forth therein, it is determined that there will be no significant adverse impact on the environment from the proposed action as described above; and be it further

Brief Description of Proposed Action (include purpose or need): The project is to modernize and expand the nature center facilities while incorporating sustainable site features. Work includes demolition of an existing 1,331 SF building and shed, including associated asphalt, portions of existing pathway and sections of a retaining wall. A new 3,216 SF nature center building will be constructed closer to the access road. Site improvements will include new concrete areas, retaining walls, asphalt surfaces, porous pavement, and a paver walkway to enhance accessibility and sustainability. The project will also provide for full-depth asphalt replacement of the entrance road with small areas of porous pavement added alongside for additional parking. A new primary septic field and designated expansion area are proposed approximately 600 ft north of the new building footprint. Stormwater runoff from the new building will be managed through the installation of eight CULTEC chambers to provide on-site treatment and infiltration. A new well will be installed near the existing well, which will be abandoned, to serve the new nature center. The project will also provide for replacement of boardwalks, including a viewing platform near the nature center that will be reconstructed slightly larger (from 300 to 630 SF) in another area of the same wetland, which will facilitate handicapped accessibility, and the replacement of approximately 180 linear feet of deteriorating boardwalk in the same location over wetlands between Cranberry Lake and Quarry Lake.

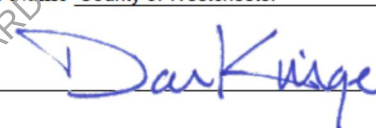

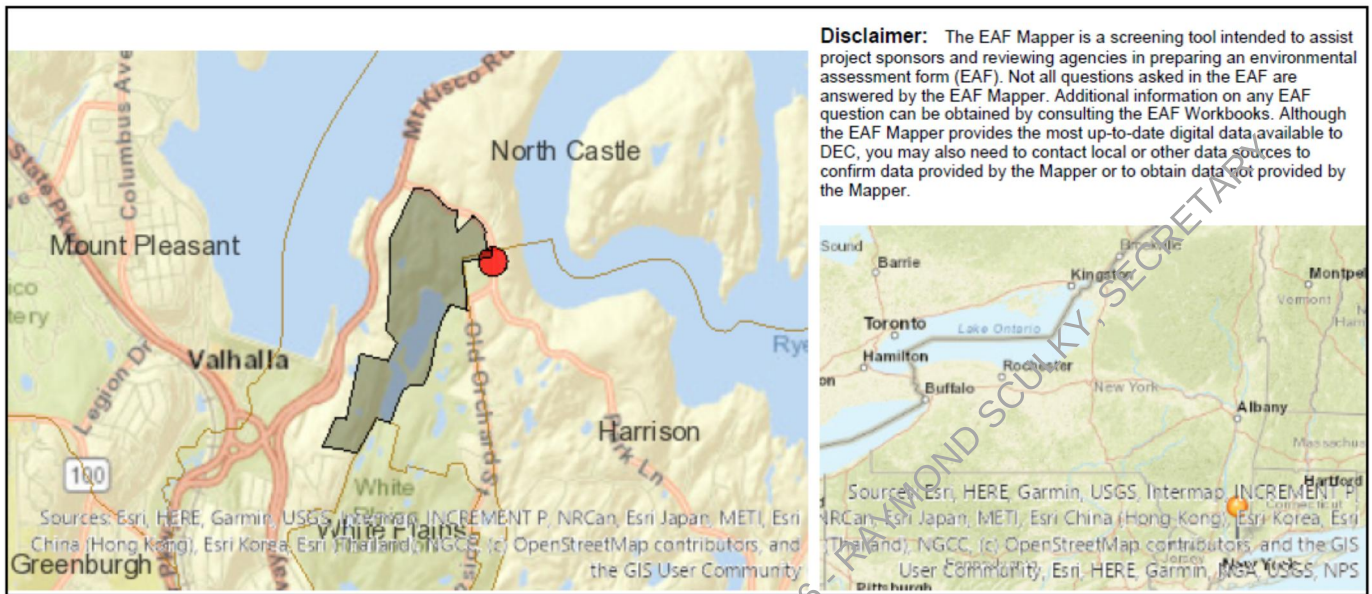
