SUBJECT: Authorization to extend the term of Agreement No. 21-905 with Paul J. Petretti, Civil Engineer & Land Surveyor from December 31, 2025 until December 31, 2027

Authority of your Honorable Board is requested to extend the term of Agreement No. 21-905 (the "Agreement") between the County of Westchester (the "County") and Paul J. Petretti, Civil Engineer & Land Surveyor (the "Consultant"), an SDVOB firm, 30 Gould Avenue, Dobbs Ferry, New York 10522, from December 31, 2025 until December 31, 2027. The original Agreement, approved on March 4, 2021, is for the provision of land surveying services at various locations in Northern Westchester County, New York which shall include areas north of Interstate 287 up to the Putnam/Westchester County border, for a total amount not to exceed \$250,000.00. The original Agreement completion date was December 31, 2023.

The Agreement was thereafter amended pursuant to a Resolution approved on April 4, 2024, ("First Amendment") to extend the term of the Agreement from December 31, 2023 to December 31, 2025.

The land surveying services included in the original Agreement are in progress. The County has been satisfied with the quality of services provided to date. The services of the Consultant will be required beyond the original completion date in order to continue providing professional services to various County departments. Attached is a Resolution requesting an extension of the Agreement from December 31, 2025 until December 31, 2027 with no increase in the not to exceed amount of \$250,000.00.

The objective of this term extension is in the County's best interest as it will provide for uninterrupted professional services pursuant to the Agreement for the Department project contained herein.

Except as specifically amended hereby, all other terms and conditions of the Agreement will remain the same.

The Department of Public Works and Transportation will track scheduling and accomplishments by the Consultant and perform on-site inspections to ensure the successful completion of this project. It is recognized and understood that the County shall evaluate the performance of this contract by the Consultant and shall use such evaluation in deciding to award future contracts to the Consultant.

I urge your favorable consideration of the annexed proposed Resolution.

RESOLVED, that the County Executive or his duly authorized designee, is hereby authorized and empowered to execute any and all documents necessary and appropriate to effectuate the purposes hereof.
