- ND SCULKY, SECRETARY AUTHORITY TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE RE: DIVISION OF CRIMINAL JUSTICE SERVICES TO ACCEPT A GRANT, IN AN AMOUNT NOT TO EXCEED \$364,750.00 IN STATE FUNDS, FOR THE DISTRICT ATTORNEY'S OFFICE TO OPERATE THE STATEWIDE TARGETED REDUCTIONS IN INTIMIATE PARTNER VIOLENCE (STRIVE) PROGRAM, FOR THE PERIOD FROM MARCH 1, 2025 THROUGH MARCH 31, 2026.

Authority is respectfully requested from your Honorable Board for the County of Westchester (the "County"), acting by and through its Office of the District Attorney (the "District Attorney's Office"), to enter into a grant agreement, known as Contract No. C485202, (the "Grant Agreement") with the New York State Division of Criminal Justice Services (the "DCJS") to accept a grant with respect to Project ID No. GD25-1092-D00, in an amount not to exceed \$364,750.00 in State funds, for the District Attorney's Office to operate The Statewide Targeted Reductions in Intimate Partner Violence (STRIVE) Program (the "Program"), for the period from March 1, 2025 through March 31, 2026.

The proposed Grant Agreement will serve a public purpose by providing funds that will enable the District Attorney' Office to operate the Program and reduce intimate partner violence throughout the County.

The goal and objective of the proposed Grant Agreement is to enhance the utilizations of evidence-based tools and approaches, including problem analysis, community readiness, and local crime analysis to identity and prioritize high-risk intimate partner violence cases to effectively respond to, mitigate, and reduce intimate partner violence throughout the County.

The goal and objective of the proposed Grant Agreement is in the best interests of the County in terms of general welfare and public safety, as the Grant Agreement will enable the District Attorney's Office to operate the Program, and is anticipated to reduce intimate partner violence throughout the County.

The goal and objective of the proposed Grant Agreement will be monitored by the District Attorney's Office and quarterly progress reports will be submitted to DCJS for its review and approval.

The proposed grant acceptance through the Grant Agreement does not constitute procurement. Accordingly, the provisions of the Westchester County Procurement Policy and Procedures do not apply.

In addition, pursuant to the Grant Agreement, the County, as the Contractor, will be required to indemnify the DCJS as follows:

> "Indemnification: The Contractor shall be solely responsible and answerable in damages for all accidents, incidents, and/or injuries to persons (including death) or property arising out of or related to the services to be rendered by the Contractor or its subcontractors pursuant to this Contract. The Contractor shall indemnify and hold harmless the State and its officers and employees from claims, suits, actions, damages, and cost of every nature arising out of the provision of services pursuant to the Contract."
