Re: Request for Authorization to Settle the Lawsuit of Marilyn Torres v. County of

Westchester in the amount of \$74,500.00.

Attached for your consideration is a resolution which, if approved by your Honorable Board, would authorize settlement of the lawsuit <u>Marriyn Torres v. County of Westchester</u> in the amount of \$74,500.00., inclusive of counsel fees.

Plaintiff Marilyn Torres, then 58 years old, brought this personal injury lawsuit against the County alleging that the County was negligent in its maintenance of the walkway located at, near and/or adjacent to the shuttle bus area of Rye Playland Park, City of Rye. Plaintiff specifically alleged that she was caused to fall on the walkway due to a dangerous condition existing thereon, identified as a hazardous and inconspicuous "parking stake base" with a missing yellow pole/top, as she traversed the walkway on her way to the bus on August 7, 2021. The parking stake base existing on the walkway at that time was missing its pole, and consequently plaintiff was not alerted to its existence as she walked, and thereupon subsequently tripped upon the parking stake base, which was the same black color as the asphalt, blending into the asphalt walkway. After she fell forward, plaintiff hit her mouth on the walkway, ultimately causing broken and missing teeth, she sustained knee contusions, disc bulges of her back, a left wrist sprain, nasal fracture, hematoma on the left side of her forehead, subsequent headaches and dizziness and was also caused to undergo physical therapy for her bilateral knee derangement.

In light of the facts and circumstances of plaintiff's fall and her alleged damages, the county determined that it was prudent to settle this matter, as it is definitely likely that the County will be found liable for plaintiff's damages. Were this matter to proceed to trial, and considering the fact that the black parking stake base was missing its yellow pole/top at the time of plaintiff's fall, a jury would conclude that it was therefore unable to alert the plaintiff and other patrons to its existence upon the walkway. Accordingly, the black base was the proximate cause of plaintiff's fall.
