Re: Authority to:

1. Enter into an agreement with the United States Department of Housing and Urban Development in order to accept a grant in the amount of \$15,610,869.00 under its Continuum of Care Competition and Noncompetitive Award of Youth Homeless Demonstration Program Renewal and Replacement Grant in support of the Rental Assistance Project, for the provision of permanent supportive housing for homeless or formerly homeless adults with one or more disabilities including mental illness and/or chemical dependency disorders, in the amount of \$15,533,360.00, for the period from June 1, 2026 through May 31, 2027; and
2. Enter into six (6) sub-recipient agreements with the agencies listed below for the provision of permanent supportive housing for homeless or formerly homeless adults with one or more disabilities including mental illness and/or chemical dependency disorders, under HUD's Continuum of Care - Rental Assistance Project, for the period from June 1, 2026 through May 31, 2027, in a total aggregate amount not-to-exceed \$15,533,360.00, in the individual amounts set forth

Authority is respectfully requested from your Honorable Board, for the County of Westchester ("County"), acting by and through its Department of Community Mental Health (the "Department") to enter into an agreement (the "Grant Agreement") with the United States Department of Housing and Urban Development ("HUD") in order to accept a grant in the amount of \$15,610,869.00, (the "Grant"), under the HUD's Continuum of Care Competition and Noncompetitive Award of Youth Homeless Demonstration Program Renewal and Replacement Grant (the "Grant") in support of the Rental Assistance Project, for the provision of permanent supportive housing for homeless or formerly homeless adults with one or more disabilities including mental illness and/or chemical dependency disorders, for the period from June 1, 2026 through May 31, 2027.

Authority is also requested from your Honorable Board for the County, acting by and through the Department, to enter into six (6) sub-recipient agreements with the agencies (“Agencies”) listed below for the provision of permanent supportive housing for homeless or formerly homeless adults with one or more disabilities including mental illness and/or chemical dependency disorders, each for a term commencing on June 1, 2026 and continuing through May 31, 2027, in a total aggregate amount not-to-exceed \$15,533,360.00, in the individual amounts set forth below and in accordance with approved budgets (the “Agreements”):

The Agencies will be reimbursed against actual expenses in accordance with the applicable regulations prescribed by HUD.

It should be noted that of the total amount of \$15,610, 869.00 in Rental Assistance Project Grant funds that HUD will provide to the County under the Grant Agreement, \$77,509.00 will be retained by the County to cover the County’s administration costs associated with the Rental Assistance Project portion of the Grant.

The proposed sub-recipient Agreements will serve a public purpose by providing permanent supportive housing for homeless or formerly homeless adults with disabilities (primarily those with serious mental illness and/or chronic problems with alcohol and/or drugs) and their families who are or are accustomed to living in places not intended for human habitation (e.g., streets), drop-ins or in emergency shelters.

The goals and objectives of the proposed sub-recipient Agreements are to provide housing and supportive services on a long-term basis for homeless or formerly homeless persons with disabilities, (primarily those with serious mental illness and/or chronic problems with alcohol and/or drugs) and their families who are or are accustomed to living in places not intended for human habitation (e.g., streets), drop-ins or in emergency shelters.

The goals and objectives of the proposed sub-recipient Agreements are in the best interests of the County in terms of fiscal responsibility and public health and safety, as those who are in need of housing will be able to find or keep housing that is in a safe and secure environment and not in the

streets. This will assist those in transition to find affordable housing and lead productive lives in Westchester County.

The goals and objectives of the proposed sub-recipient Agreements will be tracked and monitored by the Department by requiring the Agencies to complete the HUD Annual Progress Report (APR). Performance of the six (6) Agencies will be tracked using the following two outcomes:

- Increased residential stability
- Increased skill level and/or income

Because the Grant Agreement is for the acceptance of funds, the Grant Agreement does not constitute a procurement and as such it is not subject to the requirements of the Westchester County Procurement Policy and Procedures, and the Uniform Administrative Requirements, Cost Principles and Audit Requirements for Federal Awards, formerly the Common Grant Rules. In addition, since the Agencies were approved by HUD as sub-recipients through the approval of the County's application process and are approved sub-recipients under the Grant Agreement, the proposed sub-recipient Agreements may be entered on a non-competitive basis because HUD, the awarding agency, authorized such noncompetitive awards pursuant to 24 CFR 92.36(d)(4). Lastly, the proposed sub-recipient Agreements are also exempt from the Westchester County Procurement Policy and Procedures, pursuant to Section 3(a)(xviii) thereof which exempts agreements that are for the purpose of providing aid, care and support to persons in need of public assistance.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms"), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.
