Subject: Authority to exercise its first of two options to renew an agreement with Hope's Door, Inc. to provide domestic violence education services and case management services for non-residential domestic violence programs, for a renewal term commencing on January 1, 2026 and continuing through December 31, 2026 in an amount not to exceed \$81,229, pursuant to an approved budget.

Authority is hereby requested from your Honorable Board for the County of Westchester, acting by and through its Office for Women, (the "County") to exercise its first of two options to renew its agreement (the "Agreement") with Hope's Door, Inc. ("Hope's Door"), pursuant to which Hope's Door will provide domestic violence education services and case management services for non-residential domestic violence programs.

The first renewal term of the Agreement will commence on January 1, 2026 and continue through December 31, 2026 (the "First Renewal Term"). In consideration for services to be rendered during the First Renewal Term, Hope's Door will be paid an amount not to exceed \$81,229, payable quarterly pursuant to an approved budget. The County, at its sole option, may extend the term of the Agreement for one remaining extension period of one year, on the same terms and conditions as set forth in the First Renewal Term, subject to the further approval of your Honorable Board.

Hope's Door will provide the following services pursuant to the proposed Agreement:

- work with schools and communities throughout Westchester to facilitate classroom workshops, community awareness events, an annual teen symposium, and "STAR," a peer leadership program that promotes healthy relationships based on equality, respect and trust (the "Domestic Violence Education Services"); and
- provide case management services for non-residential domestic violence programs (the "Case Management Services").

The goals and objectives of the proposed Agreement are to provide educational presentations to schools and community organizations throughout Westchester regarding domestic violence, as well as case management services for non-residential domestic violence programs and overall management of program statistics and evaluation; contract development and reporting; program development; and ensuring compliance with performance measures.

The goals and objectives of the proposed Agreement are in the best interests of the County in terms of the public health, safety and general welfare, as educating teens may enable them to recognize the signs of abuse, and consequently break the cycle of violence and prevent their involvement in an abusive relationship now or in their future, thereby reducing pain and suffering, public safety costs and medical costs.

The goals and objectives of the proposed Agreement will be tracked and monitored by the Office for Women.

Accordingly, authority is respectfully sought for the County to enter into the First Renewal Term with Hope's Door.

# RESOLUTION

Upon a communication from the Westchester County Executive and the Acting Director of the Office for Women, be it hereby

**RESOLVED**, that the County of Westchester, acting by and through its Office for Women, (the "County") is hereby authorized to exercise its first of two options to renew its agreement (the "Agreement") with Hope's Door, Inc. ("Hope's Door"), for a term commencing on January 1, 2026 and continuing through December 31, 2026 (the "First Renewal Term"); and be it further

**RESOLVED**, that pursuant to the Agreement, Hope's Door will provide the following services:

- work with schools and communities throughout Westchester to facilitate classroom workshops, community awareness events, an annual teen symposium, and "STAR," a peer leadership program that promotes healthy relationships based on equality, respect and trust, and
- provide case management services for non-residential domestic violence programs

; and be it further

**RESOLVED**, that in consideration for services to be rendered during the First Renewal Term, the County shall pay Hope's Door an amount not to exceed \$81,229, payable quarterly and pursuant to an approved budget; and be it further

**RESOLVED**, that the County, at its sole option, may extend the term of the Agreement for one remaining extension period of one year, on the same terms and conditions as set forth in the Initial Term, subject to the further approval of the County's Board of Acquisition & Contract; and be it further

**RESOLVED**, that this Agreement is subject to County appropriations; and be it further

**RESOLVED**, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions reasonably necessary and appropriate to effectuate the purposes of this Resolution.
