On August 27, 2025, the County of Westchester ("County") received and opened eight (8) bids for Contract No. 25-500 Replacement of Quaker Bridge Road Bridge over Croton River, (BIN 3348560), Town of Cortlandt and Village of Croton-on-Hudson, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that C.A.C. Industries, Inc. submitted the low bid in the amount of \$11,329,575.00.
