SUBJECT: Authority to enter into an agreement with Boys & Girls Club of Mount Vernon, New York, Inc., pursuant to which Boys & Girls Club of Mount Vernon shall provide a series of youth programming including (1) Summer Program, (2) After School Program; and (3) Teen Program & Youth Development, which said programming will focus on academic enrichment, healthy lifestyles and exploration of different passions and pathways for after high school, community services and entrepreneurship, for a term commencing retroactively on January 1, 2026 and continuing through December 31, 2026, for an amount not-to-exceed \$118,858.00, pursuant to an approved budget.

Attached for your consideration is a Resolution which, if approved by your Honorable Board, would authorize the County of Westchester (the "County"), acting by and through the Westchester County Board of Legislators (the "Board"), to enter into an agreement (the "Agreement") with Boys & Girls Club of Mount Vernon, New York, Inc. ("B&G Club Mt. Vernon"), pursuant to which B&G Club Mt. Vernon shall provide a series of youth programming including (1) Summer Program, (2) After School Program; and, (3) Teen Program & Youth Development, which said programming will focus on academic enrichment, healthy lifestyles and exploration of different passions and pathways for after high school, community services and entrepreneurship. The County has entered into similar agreements with B&G Club Mt. Vernon in the past, for similar services.

The term of this Agreement will commence retroactively on January 1, 2026 and continue through December 31, 2026. In consideration for all services rendered under the Agreement, B&G Club Mt. Vernon will be paid an amount-not-to exceed \$118,858.00 payable pursuant to an approved budget.

B&G Club Mt. Vernon will provide the following services: (1) Summer Program, (2) After School Program, and (3) Teen Program. Specifically, with respect to Summer and After School Programs, B&G Club Mt. Vernon shall provide these programs that are designed to promote children's confidence and improve their thinking strategies and skills. These two programs will also include health and fitness opportunities, interactive activities that focus on positive characterization and arts and STEAM activities designed to spark imagination and creativity. In consideration for providing the Summer and After School programs B&G Club Mt. Vernon will be paid an amount not to exceed \$14,891.00 and \$82,136.00, respectively, payable pursuant to an approved budget.

Specifically, with respect to the Teen Program & Youth Development, B&G Club Mt. Vernon will provide a program designed to provide community service opportunities for teenagers and to provide an opportunity for teenagers to explore different passions and pathways and life skills for after high school. Said Teen Program will also provide youth specific wellness, cultural and conference opportunities. In consideration for providing the Youth Program & Youth Development, B&G Club Mt. Vernon will be paid an amount not to exceed \$21,831.00, pursuant to an approved budget.

The purpose of this Agreement will serve a public purpose by providing school-aged children residing in the City of Mount Vernon with youth programming designed to promote children's confidence, improve their thinking strategies and skills, academic enrichment, healthy lifestyles and exploration of different passions and pathways for after high school, and entrepreneurship.

The goals and objectives of the Agreement are to (1) provide an After School program that will serve approximately 79 children daily from the period from January 4, 2026 through June 19, 2026 and then from September 9, 2026 through December 31, 2026, (2) to provide a Summer Program that will serve approximately 124 children daily and will run from June 22, 2026 through August 21, 2026, and (3) to provide a teen program and youth development program that will serve approximately 23 children daily, and will run from January 4, 2026 through June 19, 2026 and then from September 9, 2026 through December 31, 2026.

The goals and objectives of the Agreement will be tracked and monitored by the Board, which will be responsible for monitoring B&G Club Mt. Vernon's performance by means of a performance measurement report, which shall describe how many participants took part in each of the activities set forth in the Scope of Work in the Agreement.

The Agreement is exempt from the Westchester County Procurement Policy and Procedures (the "Policy"), pursuant to Section 3 (a) xviii thereof, for any procurement for the purpose of entering into a contract or contracts with persons for the creation and support of recreation projects, youth service projects and other appropriate programs and services for the prevention of delinquency and youth crime and the advancement of the moral, physical, mental and social wellbeing of the youth of Westchester County.

Accordingly, authority is respectfully sought for the County of Westchester to enter into this Agreement.

**RESOLUTION**

Upon a communication from the Chairman of the Westchester County Board of Legislators, it is hereby:

**RESOLVED**, that authority is hereby granted to the County of Westchester (the "County") acting by and through the Westchester County Board of Legislators (the "Board"), to enter into an agreement (the "Agreement") with Boys & Girls Club of Mount Vernon, New York, Inc. ("B&G Club Mt. Vernon"), pursuant to which B&G Club Mt. Vernon shall provide a series of youth programming including (1) Summer Program, (2) After School Program; and (3) Teen Program & Youth Development, which said programming will focus on academic enrichment, healthy lifestyles and exploration of different passions and pathways for after high school, community services and entrepreneurship (the "Agreement"), for a term commencing retroactively on January 1, 2026, and continuing through December 31, 2026, in an amount not to exceed \$118,858.00, payable, pursuant to an approved budget; and be it further,

**RESOLVED**, that this Agreement is subject to County appropriations; and be it further

**RESOLVED**, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to B&G Club Mt. Vernon, then B&G Club Mt. Vernon shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

**RESOLVED**, that the Chairman of the Westchester County Board of Legislators, or his duly authorized designee, is hereby authorized to execute any documents and take such actions reasonably necessary and appropriate to effectuate the purposes of this Resolution.
