**SUBJECT:** Authority to exercise the County's option to extend the term of an agreement with Smart Moving & Storage, Inc. for one two (2) year option period, thereby increasing the amount of the agreement by \$214,080.00 and extending the term of the agreement through June 30, 2027 (Contract No. 21-210)

By resolution approved on June 9, 2022 (the "June 9<sup>th</sup> Resolution"), your Honorable Board awarded Contract No. 21-210 to Smart Moving and Storage, Inc. ("Smart Moving"). The June 9<sup>th</sup> Resolution authorized the County of Westchester (the "County") to enter into Contract No. 21-210 with Smart Moving, pursuant to which Smart Moving was to provide a Moving Services, Various Locations, Westchester County, New York in the amount of \$321,120.00, for the period from July 1, 2022 through June 30, 2025, ("Contract No. 21-210" or the "Agreement"), with the County having the sole option to extend the Agreement for one (1) two (2) year option period.

The County now seeks authority from your Honorable Board to 1) exercise the two (2) year renewal option and extend the termination date of the Agreement from June 30, 2025 to June 30, 2027; and 2) increase the amount of the Agreement by \$214,080.00 from an amount of \$321,120.00 to a new total amount not to exceed \$535,200.00.

All other terms and conditions of the June 9<sup>th</sup> Resolution and the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing efficient relocation of vital County services.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

**RESOLVED**, that the County is authorized to 1) exercise its two (2) year renewal option for Contract No. 21-210 with Smart Moving& Storage, Inc, 145 Saw Mill River Road, Yonkers, New York 10701 to provide a Moving Services, Various Locations, Westchester County, New York and extend the termination date of the Agreement from June 30, 2025 to June 30, 2027; and 2) increase the amount of the Agreement by \$214,080.00 from an amount of \$321,120.00 to a new amount not to exceed \$535,200.00; and be it further

**RESOLVED**, that except as specifically amended hereby, all remaining terms and conditions of the June 9, 2022 Resolution and the Agreement shall remain in full force and effect and unchanged; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
