- XMOND SCULKY, SECRETARY Resolution authorizing a Second Amendment to the Agreement between SUBJECT: the County of Westchester and Human Development Services of Westchester Inc., to provide homeless and eviction prevention services to very low income households residing within the Westchester Urban County Consortium and/or in municipalities that do not receive their own ESG funds, in order to change the expiration date from July 31, 2024 to August 31, 2024.

By resolution approved on February 23, 2023, your Honorable Board approved a resolution authorizing the Country of Westchester (the "County") to enter into an agreement with Human Development Services of Westchester, Inc. ("HDSW") to provide eviction prevention services throughout the Westchester Urban County Consortium communities. The term of the agreement commencing on February 1, 2023 to January 31, 2024 for an amount not-to-exceed \$75,000 in Emergency Solutions Grant ("ESG") funds (the "Agreement"). The Agreement was subsequently executed.

Thereafter, by resolution approved on October 26, 2023, the County and HDSW entered into a first amendment to the agreement in order to change the dollar amount from \$75,000 to \$225,000 an increase of \$150,000 and to change the expiration date from January 31, 2024 to July 31, 2024 (the "First Amendment"). The First Amendment was subsequently executed.

The parties now desire to further amend the Agreement to change the expiration date from July 31, 2024 to August 31, 2024. The additional time is needed to assist additional very low income households. Except as specifically provided hereby, all remaining terms and conditions set forth in the Agreement shall remain in full force and effect.

The goal and objective of this agreement is to provide eviction prevention services to very low income households residing in Westchester Urban County Consortium

communities and/or in municipalities that do not receive their own ESG funds. The program will be monitored by the Westchester County Department of Planning staff, who will review all payment requests to ensure all contractual requirements are met.

Act # 12-2022, adopted June 30, 2022, by the Westchester County Board of Legislators, authorized the County to submit an Urban County Application under the Federal Community Development Block Grant, Emergency Solutions Grant, and HOME Investment Partnership Program, including a FY 2019-2023 Consolidated Plan to include the FY 2022 Action Plan, and to accept such Grants.

The procurement of this amendment is in compliance with the County of Westchester unde, unde, constant, observal, environs contract, e Procurement Policy and Procedures, pursuant to Section 3(a)xvi, which states that contracts with recipients for disbursement of grants or loans under the Community

RESOLVED: that the County Executive or his duly authorized designee is authorized to execute any documents and take any actions necessary to effectuate the purposes hereof.
