THIONID SCULKY, SECRETARY Re: RESOLUTION AUTHORIZING THE COUNTY OF WESTCHESTER

> ("COUNTY") TO ENTER INTO AN AGREEMENT WITH ALLPAID, INC WHEREBY ALLPAID WILL OFFER A REMOTE PAY SYSTEM TO THOSE

INDIVIDUALS SENTENCED TO PROBATION WHO WISH TO USE

CREDIT CARDS OR DEBIT CARDS FOR THE PAYMENT OF RESTITUTION AND FEES REQUIRED BY THE COURT OR THE

DEPARTMENT OF PROBATION AND TO PAY FOR BAIL AT WOODFIELD JUVENILE SECURE DETENTION, AT NO COST TO THE COUNTY, FOR A TERM OF FIVE (5) YEARS COMMENCING RETROACTIVE TO JANUARY

10, 2024 AND CONTINUING THROUGH JANUARY 9, 2029.

Attached for your consideration is a Resolution, which, if approved, will authorize the County of Westchester (the "County") to enter into an agreement with AllPaid, Inc. ("AllPaid") for a term of five (5) years commencing retroactive to January 10, 2024 and continuing through January 9, 2029, whereby AllPaid will offer its remote pay system to: (i) those individuals sentenced to probation who wish to use credit cards or debit cards to pay for restitution and fees required by the Court or the Department of Probation, and (ii) those individuals remanded to Woodfield Juvenile Secure Detention who wish to use credit cards or debit cards to pay cash bail.

The card holder will be responsible to pay for all processing fees concerning the transactions directly to AllPaid, and there will be no cost to the County.

The proposed agreement does not involve procurement and is therefore exempt from the County's Procurement Policy.

The goals and objectives of this agreement are to maintain the efficiency and record keeping of the collection of restitution and fees to be paid by Probationers and bail to be paid by Adolescent Offenders and Juvenile Offenders. It will also limit the number of cash transactions, while offering Probationers and Offenders another alternative for the payment of fees. AllPaid has been used for the past 5 years and has been found to be a stable avenue for making credit card payments

RESOLUTION

Upon a communication from the Commissioner of Probation, be it hereby

RESOLVED, that the County of Westchester ("County"), acting by and through its Department of Probation, is authorized to enter into an agreement with AllPaid, Inc. ("AllPaid") commencing retroactive on January 10, 2024 and continuing through January 9, 2029, whereby AllPaid shall offer a remote pay system to (i) those individuals sentenced to probation who wish to use credit cards or debit cards for the payment of restitution and fees required by the Court or the Department of Probation, and (ii) those individuals remanded to the Woodfield Juvenile Secure Detention who wish to use credit cards or debit cards for the payment of cash bail. All processing fees associated with these transactions shall be paid by the card holder directly to AllPaid, and there shall be no cost to the County; and be it further

RESOLVED, that the County Executive or his authorized designee is authorized and empowered to execute and deliver all instruments and take all actions necessary or appropriate to effectuate the purposes hereof.
