- MOND SCULICK SECRETARY Authorization to Enter into an Agreement with Open Door Family Medical Center, Inc. to RE: accept funding for the WIC Community Innovation and Outreach ("CIAO") project, in the notto-exceed amount of \$32,000, pursuant to an approved budget, for the period from January 6, 2025 through December 31, 2026

The County of Westchester, acting by and through its Department of Health ("WCDH") seeks authorization to enter into an agreement with Open Door Family Medical Center, Inc. ("Open Door") to accept funding for the WIC Community (novation and Outreach ("WIC CIAO") project in the not-toexceed amount of \$32,000, pursuant to an approved budget, for the period from January 6, 2025 through December 31, 2026.

This program's public purpose is to promote the public health and general welfare of Westchester County residents by building or improving partnerships between WIC Local Agencies, of which the WCDH is one, and working with Head Start and Early Head Start Centers to make referrals to improve the participant experience and meet the goals of WIC CIAO. These efforts will safeguard the health of women, infants and children at high risk that would otherwise have no or limited access to nutritious foodand health education, thus improving birth outcomes and child development.

This WICCIAO funding will serve to enhance the WIC services provided by the WCDH to its clients.

The yoals and objectives will include:

- Formalizing partnerships between Early Head Start/ Head Start (EHS/HS) and local WIC agencies to create a bidirectional referral framework, collaborate on the EHS/HS Health Services Advisory Committee, cross train WIC and EHS/HS staff, and identify ways to increase WIC awareness and coordinate EHS/HS and WIC services.
- Developing educational workshops about WIC foods, nutrition, and breastfeeding, and collaborating to provide educational sessions to EHS/HS families to improve retention and WIC benefits redemption.
- The successful and timely implementation of the project, including meeting quarterly deliverables as detailed in the attached work plan, and submission of quarterly vouchers, beginning January 2025.
- Establishing and maintaining agreements with The Hudson Center for Health Equity and • Quality and Open Door Family Medical Center, Inc. WIC program regarding this project.

The program will be tracked and monitored by the WCDH reporting to Open Door, on a quarterly basis, the outcomes and success of referrals to EHS/HS, results from participant surveys and analysis of data, the number of participants attending educational sessions and workshops, as well as a description of the overall scope of services provided and documents produced.
