THIONID SCULLY, SECRET Resolution Authorizing the County of Westchester to enter into Re:

a Film Permit with Eye on the Ball Enterprises, Inc. to

retroactively authorize filming at the Westchester County Airport

on May 29, 2024 for an estimated fee of \$51,775.

Authority is requested for the County of Westchester (the "County"), by and through its Office of Tourism & Film, to retroactively enter into a Film Permit with Eye on the Ball Enterprises, Inc. to utilize locations at the Westchester County Airport, to film scenes for a television program entitled "Recess" on May 29, 2024. This request is being made because the film permit, which authorizes an estimated fee of \$51,775, to be paid to the County, requires your Honorable Board's approval. This film permit will result in revenue for the County and will also promote the County and provide revenue for local businesses

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing. Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board's approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with Eye on the Ball Enterprises, Inc. is attached for your Honorable Board's approval.
