- SCULAN, SECRETARY Resolution authorizing an agreement between the county of Westchester SUBJECT: and Caritas of Port Chester, Inc. d/b/a Meals on Main Street to renovate the existing kitchen located at 325 West Patent Road, Mount Kisco, NY to bring it up to code for the preparation and distribution of meals to community-based organizations serving food-insecure individuals in Northern Westchester, using Community Development Block Grant – COVID-19 (CDBG-CV) program funding in an amount not to exceed \$200,000.00.

The attached resolution, if approved by your Honorable Board, would authorize the County of Westchester (the "County") to enter into an agreement with Caritas of Port Chester, Inc. d/b/a Meals on Main Street ("Caritas"), pursuant to which Caritas will expand and renovate a community kitchen located at 325 West Patent Road, Mount Kisco, NY (the "Agreement") The kitchen will be brought up to code and used for meal preparation and food distribution to community-based organizations that serve low-and moderate-income households within the 2020 Urban County Consortium who have been adversely impacted by the Coronavirus pandemic. In consideration for the services to be provided, the County will pay Caritas an amount not to exceed \$200,000 in CDBG-CV program funding, payable pursuant to an approved budget. The Agreement will commence retroactively on July 1, 2025, and continue through June 30, 2026.

The goal and objective of this Agreement is to establish a fully operational community kitchen to support the preparation and distribution of meals to food-insecure individuals in Northern Westchester. These services are specifically intended to assist low-and moderate-income households within the 2020 Westchester Urban County Consortium who have been impacted by the Coronavirus pandemic. The program will be monitored by staff from the Westchester County Department of Planning, who will review all payment requests to ensure compliance with contractual requirements.

This procurement is exempt from application of the Westchester County Procurement Policy and Procedures, pursuant to Section 3(a)xvi thereof, which exempts contracts with recipients for disbursement of grants or loans under the Community Development Block Grant Program. Furthermore, the Department of Planning issued a Request for

Proposals (RFP) on February 24, 2025, via the County's website, seeking submissions from eligible 501(c)(3) organizations to support low-and moderate-income households in preventing, preparing for, and responding to the Coronavirus Pandemic. Caritas submitted a proposal that met the requirements of the program and was thus awarded a contract.

Act # 20-2020, adopted March 9, 2020, by the Westchester County Board of Legislators, authorized the County to submit an Urban County Application under the Federal Community Development Block Grant, Emergency Solutions Grant, and HOME Investment Partnership Program, including a FY 2019-2023 Consolidated Rian and to accept such Grants.
