On October 16, 2024 bids were received and opened for 2025 and 2026 Primary, Early, Special and General Election Moving Services and Storage of Handicapped Accessibility Equipment between the County Warehouse and Various Polling Place Locations in Westchester County for ZONE 1 - Cortlandt, Ossining, Peekskill, Somers and Yorktown, Contract No. BOE 24H (Z-1); ZONE 2 - Bedford, Lewisboro, Mount Kisco, New Castle, North Castle, North Salem, Mount Pleasant and Pound Ridge, Contract No. BOE 24H (Z-2); and ZONE 4 – Mamaroneck, New Rochelle, Rye Town and Rye City,

The bids were reviewed by the Westchester County Board of Elections ("Board of Elections").

It was determined that AM-PM Super Movers, Inc. submitted the second lowest bids for Zone 1 in the amount of \$121,696.06, Zone 2 in the amount of \$97,543.99, and Zone 4 in the amount of \$96,896.09. Pursuant to the bid specifications, the Handicap Moving & Storage work is separated into six zones, and no bidder can be awarded more than three out of the six zones. The low bidder for three of the Zones (Zones 3, 5 and 6) was also the low bidder for Zones 1, 2 and 4, and may not be awarded more than three zones. Therefore, the second lowest bid of AM-PM Super Movers, Inc. is recommended for award for Zones 1, 2 and 4.

Authority is hereby requested to award Contract No. BOE 24M (Z-1), Contract No. BOE 24H (Z-2), and Contract No. BOE 24H (Z-4) to the second lowest bidder, AM-PM Super Movers, Inc.

The Board of Elections conducted an investigation and it has been found that AM-PM Super Movers, Inc.

The public purpose, as well as the goal and objective of this contract, is to allow the Board of Elections to carry out its statutory duties in connection with all upcoming 2025 and 2026 Primary, Special, Early and General Elections and to ensure that all eligible County residents have the opportunity to exercise their right to vote. County Board of Elections staff will monitor the contractor's performance of the contract.

It is my recommendation that Contract Nos. BOE 24H (Z-1), BOE 24H (Z-2) and BOE 24H (Z-4) be awarded to AM-PM Super Movers, Inc., in the total amount not to exceed \$316,136.14, payable pursuant Japle ARD OF ACQUISTION & to an approved budget and subject to appropriations.

RESOLVED, that Contract Nos. **BOE 24H (Z-1), BOE 24H (Z-2), and BOE 24H (Z-4)** be awarded to the second lowest bidder for 2025 and 2026 Primary, Early, Special and General Election Moving Services and Storage of Handicapped Accessibility Equipment between the County Warehouse and Various Polling Place Locations in Westchester County and are hereby awarded to AM-PM Super Movers, Inc., 1512 Schorr Place, Bronx, NY 10469 as follows:

\$121,696.06 for ZONE 1 - Cortlandt, Ossining, Peekskill, Somers and Yorktown \$97,543.99 for ZONE 2 - Bedford, Lewisboro, Mount Kisco, New Castle, North Castle North Salem, Mount Pleasant and Pound Ridge, \$96,896.09 for ZONE 4 -Mamaroneck, New Rochelle, Rye Town and Rye City;

in the total amount not to exceed \$316,136.14 payable pursuant to an approved budget; and be it further

RESOLVED, that this Agreement is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
