SCULK, SECRETARY Authority to amend a short-form contract with The Slatin Group, LLC to provide accessible Re: tourism training through in-person and online workshops, for a term commencing on August 1,2024 and continuing through May31, 2025, for an amount not-to-exceed \$34,000, by 1) extending the term of the agreement through December 31, 2025, and 2) increasing the total amount not-to-exceed thereunder by an additional \$24,742, to an amount not-to-exceed \$58,742, payable pursuant to an approved budget.

In 2024, following a Request for Proposals process, the County of Westchester ("County") entered into a "short-form" contract with The Slatin Group, LLC ("Slatin") to provide accessible tourism training through in-person and online workshops, for a term commencing on August 1,2024 and continuing through May31, 2025, for an amount not-to-exceed \$34,000 (the "Agreement").

The services under the Agreement include in-person sessions targeted to tourism and hospitality partners with experts wrapping the elements of service accessibility blueprint and marketing for inclusive and accessible travel followed by questions and answers and development of a guide to sensory friendly travel in the County. In addition, new content creation of accessible travel for leisure itineraries business group travel.

Authority is requested to amend the Agreement by 1) extending the term of the Agreement through December 31, 2025, and 2) increasing the total amount not-to-exceed thereunder by an additional \$24,742, to an amount not-to-exceed \$58,742, payable pursuant to an refrect. approved budget. All other terms and conditions of the Agreement will remain in full force and

As your Honorable Board is aware, amendments to short-form contracts that result in increases exceeding the \$35,000 threshold for short-form contracts and/or terms beyond the one (1) year threshold, must first be approved by your Honorable Board. Accordingly, authority is respectfully requested to amend the Agreement as described.

The goals and objectives of this Agreement are to enable Westchester County Tourism & Film to produce inclusive, educational B2B workshops for tourism partners, promote best practices in the tourism industry, create a comprehensive accessible tourism toolkit, and develop

and promote tourism itineraries for visitors of all abilities in order to increase consideration and intent to travel. The Office of Tourism and Film will monitor work under the Agreement.
