Authority for the Conservation agreement with Westchester Knicks, LLC, to use the Westchester County Center for the purpose of staging NBA G League basketball games in order for the County to exercise the mutually agreed upon option to extend the term of the agreement for an additional one (1) year period from May 1,

2025 through April 30, 2026.

By Resolution approved on June 202024, your Honorable Board approved Contract No. PRC-1434 between the County of Westchester ("County") and the Westchester Knicks, LLC, ("Licensee") to use the Westchester County Center ("County Center") for the purpose of staging NBA G League ("NBAGL") basketball games and for the use of certain other areas located at the County Center in connection with such games including locker rooms, office space, storage and parking ("Agreement"). The Agreement was duly executed.

Pursuant to the Agreement the parties, upon mutual consent, have an option to renew the Agreement for an additional one-year period ("Option"). The parties have mutually agreed to terms and desire to exercise the Option to extend the term of the Agreement for an additional one (1) year period commencing on May 1, 2025 and continuing through April 30, 2026 pursuant to the following terms:

Section 3 of the Agreement shall be amended to increase the Game Day License Fee to Eight Thousand Nine Hundred and Fifty-Five and 39/100 (\$8,955.39) Dollars per game.

All other terms and conditions of the Agreement shall remain in full force and effect.

I respectfully recommend your Honorable Board's approval of the attached Resolution.

## RESOLUTION

Upon a communication from the Commissioner of Parks, Recreation and Conservation, be it hereby

**RESOLVED**, that the County of Westchester (the "County"), acting by and through its Department of Parks, Recreation and Conservation, is authored to enter into an amendment to the license agreement with the Westchester Knicks, LLC to use the Westchester County Center ("County Center") for the purpose of staging NBA G League basketball games and for the use of certain other areas located at the County Center in connection with such games including locker rooms, office space, storage and parking ("Agreement") in order to exercise the option to extend the term of the Agreement for an additional one (1) year period from May 1, 2025 through April 30, 2026 ("Option Term"); and be it further

**RESOLVED**, that the Agreement shall be amended to increase the Game Day License Fee to Eight Thousand Nine Hundred and Fifty Five and 39/100 (\$8,955.39) Dollars per game; and be it further

**RESOLVED**, that except as specifically amended hereby, all remaining terms and conditions of the Agreement shall remain in full force and effect and unchanged; and be it further

**RESOLVED**, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof
