On May 6, 2026, the County of Westchester ("County") received and opened five (5) bids for Contract No. 24-530-Rev. for Electrical Service Upgrade, Mohansic Golf Course, Yorktown Heights, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that J.T. Oronzio General Contracting & Development Inc., a WBE firm, submitted the low bid in the amount of \$1,615,000.00.
