RE: Authority to amend grant agreements with New York State, acting by and through its Office

for the Aging, to increase their total aggregate not-to-exceed amount by \$350,232.22 from an amount not to exceed \$4,011,370.00 to a new total aggregate amount not to exceed \$4,361,602.22, to provide adjusted funding for the provision of various support services for the elderly under Titles III-B, III-O and the Nutrition Services Incentive Program, III-D, and

III-E of the Older Americans Act.

By resolution approved on February 22, 2024, your Honorable Board authorized the County of Westchester ("County"), acting by and through its Department of Senior Programs and Services ("Department"), to enter into grant agreements ("Grant Agreements") with New York State, acting by and through its Office for the Aging, to accept grant funds in a total aggregate amount not to exceed \$4,011,370.00 for the provision of various support services for the elderly under Titles III-B, III-C and the Nutrition Services Incentive Program ("NSIP"), III-D, and III-E of the Older Americans Act, for the term commencing retroactively on January 1, 2024 and continuing through December 31, 2024, except for the NSIP grant agreement, which was for the term commencing retroactively on October 1, 2023 and continuing through September 30, 2024. The Grant Agreements were subsequently executed.

The County now seeks authority from your Honorable Board to amend the Grant Agreements to increase their total aggregate not-to-exceed amount by \$350,232.22 from an amount not to exceed \$4,011,370.00 to a new total aggregate amount not to exceed \$4,361,602.22, to provide adjusted funding for the provision of various support services for the elderly under Titles III-B, III-C and the Nutrition Services Incentive Program, III-D, and III-E of the Older Americans Act. The individual funding for each grant agreement will be modified and allocated according to the table below:

All other terms and conditions of the Grant Agreements shall remain unchanged.

The additional funds provided under the Title III-C grant agreements will be used to reimburse providers for 2024 overserved meal units. The additional funds provided under the Title III-D grant agreement will be retained by the Department for direct services to seniors.

The goals and objectives of the Grant Agreements are to continue to allow County seniors to stay and/or live in their homes and/or communities and avoid placement in institutions. The various services provided through the Grant Agreements will assist in attaining these goals/objectives by providing community maintenance for County seniors.

The goals and objectives of the Grant Agreements are in the best interest of the County because they serve as a means of providing funding to expand services to seniors, especially those seniors who are at increased risk of isolation and malnutrition in an effort to delay or divert them from institutionalization, thereby reducing Medicaid costs to the County.

The goals and objectives of the Grant Agreements are tracked and monitored through monthly reporting activities and reviews to determine if performance goals and objectives of the Grant Agreements are being met in a fiscally responsible and appropriate fashion.

The Grant Agreements are for the acceptance of grant funds; therefore, they do not constitute procurements. Accordingly, the Grant Agreements are not subject to the Westchester County Procurement Policy and Procedures.

I certify that my Department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant ("Grant Terms"), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

Accordingly, I respectfully recommend your Honorable Board's approval of the attached Resolution.
