Resolution authorizing the County of Westchester to enter into a permit SUBJECT:

> agreement with the City of Peekskill School District for use of the Auditorium at the District's Administration Building located at 1031 Elm Street in Peekskill on Thursday, November 13, 2025, between the hours of 4:00 P.M. and 8:00 P.M., to hold a public listening session, and to agree

to hold harmless and indemnify the District in connection therewith.

Authority is sought for the County of Westchester (the "County"), acting by and through its Beard of Legislators (the "Board"), to enter into a permit agreement with the City of Peekskill School District (the "District") for the use of the Auditorium at the District's Administration Building located at 1031 Elm Street in Peekskill on Thursday, November 13, 2025, between the hours of 4:00 P.M. and 8:00 P.M., to hold a public listening session in connection with the 2026 County Budget (the "Permit"). The Board expects between 50 to 100 attendees at the session.

The Board has advised that the District has requested that the County agree to indemnify it, in writing, for any damage and/or injury that may result from the County's usage of its property in connection with the public information session. Accordingly, if approved by your Honorable Board, the attached resolution would also authorize the County to agree as follows:

## RESOLUTION

Upon a communication from the Chairman of the Westchester County Board of Legislators, it is hereby:

**RESOLVED**, that the County of Westchester (the "County"), acting by and inrough its Board of Legislators, is hereby authorized to enter into a permit agreement with City of Peekskill School District (the "District") for the use of the Auditorium at the District's Administration Building located at 1031 Elm Street in Peekskill on Thursday, November 13, 2025, between the hours of 4:00 P.M. and 8:00 P.M., to hold a public listening session in connection with the 2026 County Budget (the "Permit"); and be it further

**RESOLVED**, that the County will agree to indemnify and finid harmless the District, as follows:

"[The County of Westchester] does hereby covenant and agree to indemnify and hold harmless the Peekskill City School District, from and against any and all liability, loss, damages, claims or actions (including costs and attorney's fees) for bodily injury and/or property damage, to the extent permitted by law, arising out of or in connection with the actual use of the Peekskill City School District's property, facilities and/or services by the above named organization."

; and be it further

RESOLVED, that the Permit fee shall be waived; and be it further

**RESOLVED**, that the Chairman of the Westchester County Board of Legislators, or his duly authorized designee, is hereby authorized to execute any documents and take such actions reasonably necessary and appropriate to effectuate the purposes of this Resolution in the manner prescribed by law.
