Re: Authority to enter into an agreement with the New York State Governor's Traffic Safety Committee to accept a gran in the amount of \$40,548 for the Department of Public Safety Services to participate in the Statewide Police Traffic Safety Program for the term October 1, 2022 through September 30, 2023.

Authority is requested for the County of Westchester ("County"), acting by and through the Department of Public Safety Services ("Public Safety"), to enter into an agreement with the New York State Governor's Traffic Safety Committee ("NY") to accept a grant (No. T006910) in the amount of \$40,548 ("Grant") for Public Safety to participate in the Statewide Police Traffic Safety Program for the term October 1, 2022 through September 30, 2023 (the "Agreement").

The Statewide Police Traffic Safety Program aims increase seat belt usage and reduce dangerous driving behaviors in an effort to reduce serious injury and death from traffic crashes. The proposed Grant will be utilized to provide both seat belt mobilization enforcement and regular police traffic services enforcement. Statewide Police Traffic Safety Program supports salary, and overtime to provide enhanced enforcement.

The Grant will serve a public purpose by enhancing the ability of Public Safety to enforce seatbelt and other infractions to reduce dangerous driving and decrease serious injuries in the County.

Public Safety will track and monitor the use of grant funds through progress reports provided to NY.
