RE: Authorization to enter into an agreement with each of twenty-two (22) parties, pursuant to each of which each party will provide information technology professional consultant services, as specified below, for a term from April 1, 2025 through March 31, 2028, for a total aggregate amount not to exceed \$16,752,105.96 for all such agreements.

BACKGROUND:

- On November 26, 2024, the County issued a request for proposals ("RFP") seeking proposals from qualified individuals and companies to provide various information technology professional consultant services.
- The RFP specified that the County anticipates having projects with various, uncertain needs for various information technology professional consultant services over the next three (3) years. Based upon the uncertainty that is anticipated, the County prepared a very comprehensive "Services List" as part of the RFP, specifying the services that the County expects that it may need.
- The RFP specified that County is aware that, for a certain project, a given consulting entity may have more applicable experience, or more available resources, or some other distinguishing characteristic(s) that make its offer of the necessary services more advantageous than the offer of the services from other consulting entities. Therefore, the RFP specified that the County was seeking to contract with one or more proposers for each of the services on the Services List that the County intended to award and make available to itself.
- The RFP specified that each such authorized contract with a proposer would specify the applicable basic contract terms, including the maximum hourly rate for the services on the Services List for which that contract had been awarded to the proposer.
- The RFP specified that each proposer that contracted with the County for a given service from the Services List would be then be eligible, for the full term of the contract, to be considered by the County for each individual project, as those individual project opportunities arise over time.

- The RFP specified that, for each such individual project, the County would consider each eligible contractor's characteristics and pricing in determining which eligible contractor to retain for the individual project at issue. The RFP specified that, as part of that process, the County may require that the eligible contractor provide updated and/or further information about its resources and capabilities, including, but not necessarily limited to, samples of relevant work and information about the particular consultants/programmers who would be made available to the County for that project.
- The RFP specified that the eligible contractor selected for a given individual project would be paid at an hourly rate not-to-exceed the hourly rate specified in that eligible contractor's contract with the County for the applicable service at issue. The RFP specified that the maximum, not-to-exceed hourly rates in each eligible contractor's contract with the County will not be increased during the term of that contract, irrespective of anything that may occur in the meantime and irrespective of the County's particular needs for a given individual project.
- In response to the RFP, the County received responsive proposals from a total of sixty (60) proposers for various of the one hundred and twenty-three (123) services on the Services List, for which proposals were solicited.
- The County is now seeking to contract with twenty-two (22) of the sixty (60) proposers for various of the services on the Services List (each such proposer being an "Eligible Contractor" for each of the services).
- The details about the agreements for which authority is sought for various information technology professional consultant services (collectively, the "Agreements") are set forth below, and attached hereto is the list of proposers for each service listed below.
