SUBJECT: Resolution Authorizing the Agreement between the County of Westchester, Linear Environmental Corp., and 28-30 Holdings LLC for Lead-Based Paint Improvements in common areas on the 6th and 7th floors of the property located at 30 Locust Hill Avenue in Yonkers, New York.

The attached resolution, if approved by your Honorable Board, would authorize the County of Westchester (the "County") to enter into an agreement (the "Agreement") with Linear Environmental Corp. (the "Contractor") and 28-30 Holdings LLC (the "Property Owner"), pursuant to which the Contractor will make repairs in common areas on the 6th and 7th floors that include the hallway and lobby at 30 Locust Hill Avenue in Yonkers (the "Property") through the Lead Safe Westchester ("LSW") Program, a program designed to reduce lead-based paint hazards. In consideration for services rendered, the County will pay the Contractor an amount not to exceed \$137,000 pursuant to an approved budget. The term of the Agreement will commence on February 15, 2026 and continue through June 30, 2026.

The LSW Program will finance repairs completed by an EPA Certified Contractor to stabilize deteriorated lead-based paint at the Property that have been identified in lead inspections and risk assessments.

The goal and objective of this agreement is to provide a safe and healthy environment for the residents of this Property. The project will be monitored by Department of Planning staff who will make site visits during the construction to ensure all contractual obligations are met.

In accordance with Section 5 of the County's Procurement Policy and Procedures, the Department of Planning (the "Department") solicited written quotations from EPA certified lead contractors for the services described above. Four (4) price quotations, submitted by AltaVista Lead Improvements, Inc., WPS Contracting Group, LLC, Enviro NYC and Linear Environmental Corp., were received in response to the Department's efforts. Linear Environmental Corp. submitted the most advantageous offer with the best value as this firm is the most experienced in managing hazardous materials with

minimal disruption and exposure by residents to lead dust during renovations and was thus awarded this Agreement.

On January 12, 2023, the Board of Acquisition and Contract approved a resolution authorizing the County of Westchester to enter into a grant agreement with the United States Department of Housing & Urban Development, Office of Lead Hazard Control and Healthy Homes for an amount totaling \$4,100,000.00 to reduce lead-based paint hazards in Westchester County.

I recommend approval of this agreement.

RESOLUTION

UPON A COMMUNICATION FROM THE COMMISSIONER OF PLANNING, BE IT HEREBY

RESOLVED, that the County of Westchester (the "County") is hereby authorized to enter into an agreement with Linear Environmental Corp. (the "Contractor") and 28-30 Holdings LLC (the "Property Owner"), pursuant to which the Contractor will make repairs in common areas on the 6th and 7th floors that include the hallway and lobby at 30 Locust Hill Avenue in Yonkers, NY (the "Property") through the Lead Safe Westchester (the "LSW") Program for an amount not to exceed \$137,000, payable pursuant to an approved budget, for a term commencing on February 15, 2026 and continuing through June 30, 2026, and be it further;

RESOLVED, that the work will include, but not be limited to, repairing deteriorated areas identified in lead inspections and risk assessments, and be it further,

RESOLVED, that the County Executive or his duly authorized designee is authorized to execute any documents and take any actions necessary to effectuate the purposes hereof.
